**AMENDED CONSENT ORDER**

---

**JURISDICTION AND PROCEDURAL HISTORY**

The Virginia Board of Nursing (“Board”) and Shemeka Antioentte Pannell, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Pannell’s application for reinstatement of her certificate to practice as a nurse aide in the Commonwealth of Virginia.

**FINDINGS OF FACT AND CONCLUSIONS OF LAW**

1.       Shemeka Antioentte Pannell was issued Certificate Number 1401-102904 to practice as a nurse aide on April 12, 2004, which expired on April 30, 2010.
2.       Shemeka Antioentte Pannell submitted an application for the reinstatement of her certificate to practice as a nurse aide in the Commonwealth of Virginia on February 25, 2016.
3.       Ms. Pannell violated Virginia Code § 54.1-3007(4) in that she has been convicted of multiple felonies in the Circuit Court of Campbell County, Virginia. Specifically, she pled guilty on January 22, 2010 to one count of distribution of cocaine and three counts of distribution of cocaine, second offense, and, on July 28, 2010, she pled guilty to two counts of distribution of cocaine second offense. She was sentenced on September 25, 2010, to a total of 55 years incarceration, with all time but 4 years and 11 months suspended on the condition that she keep the peace and be of good behavior for 10 years. She was placed on three years supervised probation and ordered to pay restitution.

4. Ms. Pannell performed nursing related activities for compensation in the two years prior to the expiration of her certificate, and within the preceding two years, and therefore pursuant to 18 VAC 90-25-80(B)(1)(a) of the Regulations Governing Certified Nurse Aides, meets the requirements for reinstatement of her nurse aide certificate.

### CONSENT

Shemeka Antioentte Pannell, by affixing her signature to this Consent Order, agrees to the following:

1. I have been advised to seek advice of counsel prior to signing this document;
2. I am fully aware that without my consent, no legal action can be taken against me or my certificate except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 *et seq.*;
3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; the right to representation by counsel; and the right to cross-examine witnesses against me;
4. I waive all right to an informal conference;
5. I admit to the Findings of Fact and Conclusion of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
6. I consent to the entry of the following Order affecting my application for the reinstatement of my certificate to practice as a nurse aide in the Commonwealth of Virginia.


### ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:


1. The application of Shemeka Antioentte Pannell for certification to practice as a nurse aide in the Commonwealth of Virginia is APPROVED. Shemeka Antioentte Pannell shall be issued an unrestricted certificate..
2. Shemeka Antioentte Pannell is REPRIMANDED.
3. Shemeka Antioentte Pannell shall comply with all laws and regulations governing the practice of nurse aides in the Commonwealth of Virginia.

Pursuant to Virginia Code §§2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.


