CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Christian Victoria Wray, L.P.N., as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Wray's license to practice as a practical nurse in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Christian Victoria Wray, L.P.N. was issued License Number 0002-083661 to practice as a practical nurse on October 28, 2010, which is scheduled to expire on June 30, 2017. Her primary state of residence is Virginia.
- 2. Ms. Wray violated Virginia Code § 54.1-3007(2) and (5) and 18 VAC 90-20-300(A) (2)(d) and (i) of the Regulations Governing the Practice of Nursing in that on March 23, 2015, in the course of her employment with Trinity Mission Health & Rehab of Rocky Mount, Rocky Mount, Virginia:
- a. Ms. Wray delegated to a certified nurse aide the task of initiating a Patient A's G- tube feeding, which is beyond the scope of nurse aide practice. In addition, Ms. Wray did not review Patient A's orders and instructed the certified nurse aide to perform the incorrect procedure.
- b. Ms. Wray delegated the administration of Patient B's medication to at least two certified nurse aides who were not licensed by the Board of Nursing to administer medication.

4. No harm to either patient resulted from Ms. Wray's act.

CONSENT

Christian Victoria Wray, L.P.N., by affixing her signature to this Consent Order, agrees to the following:

- 1. I have been advised to seek advice of counsel prior to signing this document;
- 2. I am fully aware that without my consent, no legal action can be taken against me or my license except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; the right to representation by counsel; and the right to cross-examine witnesses against me;
 - I waive all right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusion of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my right to practice as a practical nurse in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. Christian Victoria Wray, L.P.N. is REPRIMANDED.
- 2. Within 60 days from the date of entry of this Order, Christian Victoria Wray shall provide written proof satisfactory to the Board of successful completion of the following NCSBN courses:

- a. Delegating Effectively; and
- b. Professional Accountability & Legal Liability for Nurses.
- 3. Christian Victoria Wray shall comply with all laws and regulations governing the practice of practical nursing in the Commonwealth of Virginia.
- 4. Any violation of the foregoing terms and conditions of this Order or any statute or regulation governing the practice of practical nursing shall constitute grounds for further disciplinary action.

Pursuant to Virginia Code §§2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
