If you fail to appear at the formal hearing, the Committee may proceed to hear this matter in your absence and may take any of the actions outlined above.

You have the right to the information on which the Committee will rely in making its decision, to be represented by counsel at this proceeding, to subpoena witnesses and/or documents, and to present relevant evidence on your behalf.

NOTE: Failure to object to the distribution of the Commonwealth's exhibits prior to the proceeding will not affect your right to contest any information contained in these documents at the proceeding.

STATEMENT OF ALLEGATIONS

The Board of Nursing alleges that:

- 1. At all times relevant hereto, Arlene Frances White, R.M.A. was registered to practice as a medication aide in the Commonwealth of Virginia.
- 2. Arlene Frances White, R.M.A. violated Virginia Code § 54.1-3007(2), (5), and (8) and 18 VAC 90-60-120(2)(f) of the Regulations Governing the Registration of Medication Aides ("Regulations") in that during the course of her employment with Roselawn Rest Home, Castlewood, Virginia:
- a. In or about November and December 2015, Ms. White failed to provide or obtain appropriate medical care for Resident A, who was experiencing severe skin breakdowns and tears, fall-related wounds, disorientation, and altered mental status.
- b. In or about November and December 2015, Ms. White failed to administer medications in accordance with physician's orders and consistent with the standards of practice in that she administered multiple topical medications and dressings to Resident A without a physician's order, after the physician had ordered only an over-the-counter cream for the resident.
- c. In or about November and December 2015, Ms. White failed to notify the Virginia Department of Social Services that Resident A was experiencing pressure ulcers and serious skin breakdowns.
- 3. Ms. White violated Virginia Code § 54.1-3007(2), (5), and (8) and 18 VAC 90-60-120(2)(a) and (f) of the Regulations in that during the course of her employment with Roselawn, Ms. White performed wound care on Resident A, including treating and medicating wounds without a physician's order.
