CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Roy Aaron Cash, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Mr. Cash's application for registration by examination to practice as a medication aide in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Roy Aaron Cash submitted an application for registration by examination to practice as a medication aide in the Commonwealth of Virginia on February 18, 2016.
- 2. Mr. Cash violated Virginia Code § 54.1-3007(4) in that on November 4, 2015, in the General District Court of Harrisonburg/Rockingham County, Virginia, Mr. Cash was convicted of petit larceny, a misdemeanor involving moral turpitude.
- 3. Mr. Cash was sentenced to 180 days in jail, suspended, and placed on unsupervised probation for one year. He was also ordered to pay \$468.00 in court costs, for which he entered into an installment or deferred payment agreement.
 - 4. Mr. Cash otherwise meets the requirements of Virginia Code § 54.1-3042.

CONSENT

Roy Aaron Cash, by affixing his signature to this Consent Order, agrees to the following:

1. I have been advised to seek advice of counsel prior to signing this document;

- 2. I am fully aware that without my consent, no legal action can be taken against me or my registration except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; the right to representation by counsel; and the right to cross-examine witnesses against me;
- 4. I waive all right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusion of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my application for registration to practice as a medication aide in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. The application of Roy Aaron Cash for registration by examination as a medication aide is APPROVED. Upon successful completion of the medication aide examination, Mr. Cash shall be issued an unrestricted registration to practice as a medication aide in the Commonwealth.
 - 2. Mr. Cash is hereby REPRIMANDED.
- 3. Mr. Cash shall maintain a course of conduct in his capacity as a medication aide commensurate with the requirements of § 54.1-3000 *et seq*. of the Code and the Regulations Governing the Registration of Medication Aides.
