CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Tarris Riann Finney, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Finney's application for certification by endorsement to practice as a nurse aide in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- Tarris Riann Finney submitted an application for certification by endorsement to 1. practice as a nurse aide in the Commonwealth of Virginia on February 19, 2016. Ms. Finney held certification No. DE000041340708 to practice as a nurse aide in the state of Delaware. Said certificate expired on March 23, 2016.
- Ms. Finney violated Virginia Code § 54.1-3007(1) and (4) in that on her application she 2. answered "no" to the question "Have you ever been convicted, pled guilty to, or pled no contest to the violation of any federal, state, or other law constituting a felony or misdemeanor. . ." when, in fact, she was convicted in the Superior Court of Delaware on May 2, 2002, of one count of second degree robbery, a felony.
 - Ms. Finney otherwise meets the requirements of Virginia Code §54.1-3024. 4.

CONSENT

- 2. I am fully aware that without my consent, no legal action can be taken against me or my certificate except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; the right to representation by counsel; and the right to cross-examine witnesses against me;
- 4. I waive all right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusion of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my application for certification to practice as a nurse aide in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. The application of Tarris Riann Finney for certification as a nurse aide by endorsement is hereby APPROVED. The Board shall issue Ms. Finney an unrestricted certificate to practice as a nurse aide in the Commonwealth of Virginia.
 - 2. Ms. Finney is hereby REPRIMANDED.
- 3. Ms. Finney shall maintain a course of conduct in her capacity as a nurse aide commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.
