ORDER

Pursuant to §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended

("Code"), a Special Conference Committee ("Committee") of the Virginia Board of Nursing ("Board") met

on April 4, 2016, in Henrico County, Virginia, to receive and act upon Titilayo O. Akadiri's application for

reinstatement of her certificate to practice as a nurse in Virginia and removal of a Finding of Neglect entered

against her in the Virginia Nurse Aide Registry, and to inquire into evidence that Ms. Akadiri may have

violated certain laws and regulations governing nurse aide practice. Ms. Akadiri was present and was

represented by Margaret Hardy, Esquire.

Upon consideration of the evidence, the Committee adopts the following Findings of Fact and

Conclusions of Law.

FINDINGS OF FACT

Titilayo O. Akadiri, C.N.A., was issued Certificate No. 1401-155846 to practice as a nurse 1.

aide in the Commonwealth of Virginia on September 26, 2012. Said certificate was suspended by Order of

the Board entered on July 23, 2014, with a Finding of Neglect, single incident, entered against her in the

Virginia Nurse Aide Registry. This action was the result of Ms. Akadiri improperly transferring a resident

that caused injury to the resident.

On September 25, 2015, Ms. Akadiri submitted an application for reinstatement of her 2.

certification to practice as a nurse aide in the Commonwealth of Virginia.

- 3. By letter dated March 1, 2016, the Board of Nursing sent a Notice of Informal Conference ("Notice") to Ms. Akadiri notifying her that an informal conference would be held on April 4, 2016. The Notice was sent by certified and first class mail to 7818 Belfield Road, North Chesterfield, Virginia 23237, the address of record on file with the Board of Nursing.
- 4. On April 4, 2016, during the informal conference, Ms. Akadiri verbally petitioned the Board for removal of the Finding of Neglect based on a single incident which was entered against her in the Virginia Nurse Aide Registry.
- 5. On her application for employment with Pleasant View Residential Services, Richmond, Virginia, dated June 2, 2015, Ms. Akadiri answered "NO" to the question "Have you ever been the subject of an allegation of abuse or neglect?" when, in fact, she was terminated from Lucy Corr Village, Chesterfield, Virginia, and her nurse aide certificate was suspended by the Board and a finding of neglect was entered against her for neglect of a resident.
- 7. On her application for employment with the Department of Corrections, Greenville Correctional Center, Jarratt, Virginia, dated September 9, 2015, Ms. Akadiri failed to list her employment with Lucy Corr Village, Pleasant View Residential Services, and Glenburnie Rehabilitation and Nursing Center.
- 8. Ms. Akadiri stated to the Committee that she last worked as a certified nurse aide at Glenburnie Rehabilitation and Nursing Center in August 2014.
- 9. Ms. Akadiri stated that she has completed two semesters of pre-requisites for the nursing program at John Tyler Community College, Richmond, Virginia.
- 10. Ms. Akadiri stated that she was currently employed as a corrections officer with the Department of Corrections, and has not had any disciplinary actions.

## **CONCLUSIONS OF LAW**

- Findings of Fact Nos. 6 and 7 constitute a violation of § 54.1-3007(2) of the Code and 18 VAC 90-25-100(2)(d) of the Regulations Governing Certified Nurse Aides.
- 2. The Committee concludes that Ms. Akadiri otherwise meets the requirements for reinstatement of her certificate to practice as a nurse aide.

## **ORDER**

On the basis of the foregoing, the Committee hereby ORDERS as follows:

- 1. The application of Titilayo O. Akadiri, C.N.A. for reinstatement of her certificate to practice as a nurse aide in Virginia is APPROVED. Ms. Akadiri shall be issued an unrestricted certificate to practice as a nurse aide. Further, Ms. Akadiri's petition for removal of the Finding of Neglect entered against her in the Virginia Nurse Aide Registry is GRANTED.
- 2. Ms. Akadiri shall maintain a course of conduct in his capacity as a certified nurse aide commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying on request.

Pursuant to Section 54.1-2400(10) of the Code, Ms. Akadiri may, not later than 5:00 p.m., on **June 8**, **2016**, notify Jay P. Douglas, M.S.M., R.N., C.S.A.C., F.R.E., Executive Director, Board of Nursing, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in writing that she desires a formal administrative hearing before the Board. Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated.
