## CONSENT ORDER

# JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Victoria Lee Coleman Hall, L.P.N., as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Hall's license to practice practical nursing in the Commonwealth of Virginia.

# FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Victoria Lee Coleman Hall, L.P.N. was issued License Number 0002-051235 to practice as a practical nurse on June 7, 1995, said license is scheduled to expire on July 31, 2017. Her primary state of residence is Virginia
- 2. Ms. Hall violated Virginia Code § 54.1-3007(2) and (5) and 18 VAC 90-20-300(2)(e) of the Regulations Governing the Practice of Nursing in that on February 28, 2015, Ms. Hall, during the course of her employment as an L.P.N. at Bassett Family Practice ("BFP"), ordered unauthorized laboratory tests on herself without an order or documentation from a Bassett practitioner.
- 3. BFP employees can receive medical care from a practitioner of BFP at no cost to the employee. Ms. Hall was receiving medical care from Tracy Lange, L.N.P with BFP.
- 4. Ms. Hall claimed that Ms. Lange authorized the verbal order for additional laboratory tests, but Ms. Lange denied doing so.

- 5. Ms. Hall phoned a verbal order for the additional unauthorized tests to the laboratory using another BSP nurse's name, Yvette Manns, L.P.N. Ms. Hall claimed Ms. Manns told her to use Ms. Manns' name for the verbal order. Ms. Manns denied giving Ms. Hall permission to use her name for the verbal order.
  - 6. Ms. Hall's employment with BFP was terminated as a result of this incident.

#### **CONSENT**

Victoria Lee Coleman Hall, L.P.N., by affixing her signature to this Consent Order, agrees to the following:

- 1. I have been advised to seek advice of counsel prior to signing this document;
- 2. I am fully aware that without my consent, no legal action can be taken against me or my license except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; the right to representation by counsel; and the right to cross-examine witnesses against me;
  - 4. I waive all right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusion of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my right to practice as a practical nurse in the Commonwealth of Virginia.

## **ORDER**

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. Victoria Lee Coleman Hall, L.P.N. is REPRIMANDED.
- 2. Victoria Lee Coleman Hall, L.P.N. shall comply with all laws and regulations governing practical nursing practice in the Commonwealth of Virginia.

Pursuant to Virginia Code §§2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
