ORDER

In accordance with §§ 2.2-4019, 2.2-4021 and 54.1-2400(10) of the Code of Virginia (1950), as amended

("Code"), an informal conference was conducted on behalf of the Board of Nursing ("Board") on February 27,

2007, in Henrico County, Virginia. Ms. Myers was present and was not represented by counsel. Jane Elliott,

R.N., Ph.D., serving as Agency Subordinate for the Board, submitted a Recommended Decision for consideration.

Based upon its review of the Recommended Decision of the Agency Subordinate, the Board makes the

following Findings of Fact and Conclusions of Law and issues the following Order.

FINDINGS OF FACT

1. Elva Myers was issued license number 0002-041486 to practice nursing in Virginia on May 19,

1989. The license was suspended on May 26, 1998, due to her conviction of certain felony offenses and her

falsification of employment applications. By Order entered December 15, 2003, the Board denied Ms. Myers'

first application for reinstatement of her license. Ms. Myers submitted a second application for reinstatement of

the license on April 20, 2006.

2. By letter dated January 26, 2007, the Board of Nursing sent a Notice of Informal Conference

("Notice") to Ms. Myers notifying her that an informal conference would be held on February 27, 2007. The

Notice was sent by certified and first class mail to 213 Burch's Mill Road, Urbanna, Virginia 23175, the address of

record on file with the Board of Nursing.

3. Ms. Myers' license to practice practical nursing in Maryland was revoked by the Maryland Board

of Nursing by Order entered July 14, 2005, as a result (in part) of the Virginia Board of Nursing's action in 1998.

4. On her application for reinstatement of her Virginia license, Ms. Myers failed to disclose the fact

that her Maryland license had been revoked.

- 5. Ms. Myers stated that she had not notified the Maryland Board of Nursing that her address had changed and did not receive the Order of Revocation from the Maryland Board. It is noted in the Maryland Order of Revocation that notice of the proceedings, sent by both certified and regular mail, had been returned to the Maryland Board as "attempted, unknown address."
 - 6. Ms. Myers' primary state of residence is Virginia.
- 7. Ms. Myers stated that she is self-employed as a commercial truck driver and has started a publishing and record business.
- 8. Ms. Myers has satisfied all terms of sentencing and probation related to the 1998 felony convictions.
 - 9. Ms. Myers denied any history of or current abuse of alcohol or controlled substances.
 - 10. Ms. Myers submitted evidence of having completed 15 continuing education credits.
- 11. Ms. Myers stated that she understood the importance of being truthful on any applications she might complete.

CONCLUSIONS OF LAW

The Board concludes that:

- 1. Finding of Fact #3 constitutes a violation of § 54.1-3007(7) of the Code.
- 2. Ms. Myers otherwise meets the requirements of § 54.1-3011 of the Code.

ORDER

WHEREFORE, it is hereby ORDERED that the license of Elva Myers be, and hereby is, REINSTATED. Ms. Myers shall be issued a single state license marked "Valid in Virginia Only."

Ms. Myers shall maintain a course of conduct in her practice of practical nursing commensurate with the requirements of Title 54.1, Chapter 30 of the Code and the Board of Nursing Regulations.

This Order is subject to appeal to the Board. If Ms. Myers desires a formal administrative hearing before the Board pursuant to Sections 2.2-4020 and 2.2-4021 of the Code, she must notify Jay P. Douglas, R.N., M.S.M.,

C.S.A.C., Executive Director, Board of Nursing, 6603 West Broad Street, Richmond, Virginia 23230, in writing, within thirty-three (33) days from the date of service of this Order. Upon the filing of a request for the hearing with the Executive Director, this Order shall be vacated.

Pursuant to Section 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
