#### **ORDER**

Pursuant to §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), a Special Conference Committee ("Committee") of the Virginia Board of Nursing ("Board") met on April 5, 2016, in Henrico County, Virginia, to receive and act upon the application of LaTaurus N. Campbell for reinstatement of her registration to practice as a medication aide in Virginia and to inquire into evidence that Ms. Campbell may have violated certain laws and regulations governing medication aide practice. Ms. Campbell was present and was not represented by legal counsel.

Upon consideration of the evidence, the Committee adopts the following Findings of Fact and Conclusions of Law.

### FINDINGS OF FACT

- LaTaurus N. Campbell was issued Registration No. 0031-007650 to practice as a medication aide in the Commonwealth of Virginia on April 25, 2014. Said registration was suspended by Order of the Board entered on May 27, 2015.
- 2. By letter dated February 29, 2016, the Board of Nursing sent a Notice of Informal Conference ("Notice") to Ms. Campbell notifying her that an informal conference would be held on April 5, 2016. The Notice was sent by certified and first class mail to 126 Engleside Drive, Apt. 2D, Richmond, Virginia 23222, the address of record on file with the Board of Nursing. The Notice was also sent to 3800 Delmont Street, Apt. G, Richmond, Virginia 23222, a secondary address.
- 3. Ms. Campbell submitted an application for reinstatement of her registration to practice as a medication aide which was received by the Board on September 21, 2015.

- 4. By Order of the Board entered May 27, 2015, Ms. Campbell's registration was indefinitely suspended due to findings that she failed to administer medications to nine residents during her shift and failed to accurately document the medication administration record.
- 5. Ms. Campbell falsified the employment application with Ashland Nursing and Rehabilitation dated August 17, 2015, in that she failed to disclose her employment with Senior Healthcare Solutions.
- 6. Ms. Campbell falsified the employment application with Senior Healthcare Solutions dated July 11, 2014, in that she failed to disclose her termination from Beth Shalom Nursing Home.
- 7. Ms. Campbell reported that she wants to further her education in nursing, but wanted to clear this matter first. She is currently unemployed.

## CONCLUSIONS OF LAW

- 1. Findings of Fact Nos. 5 and 6 constitute a violation of § 54.1-3007(2) of the Code and 18 VAC 90-20-300(A)(2)(e) of the Regulations Governing the Registration of Medication Aides.
- 2. The Committee concludes that LaTaurus N. Campbell has demonstrated satisfactory evidence that she is prepared to resume practice in a safe and competent manner.

#### <u>ORDER</u>

On the basis of the foregoing, the Committee hereby ORDERS as follows:

- 1. The registration of LaTaurus N. Campbell to practice as a medication aide in the Commonwealth of Virginia is hereby REINSTATED. Ms. Campbell shall be issued an unrestricted registration.
- 2. Ms. Campbell shall maintain a course of conduct in her capacity as a medication aide commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Regulations Governing the Registration of Medication Aides.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying on request.

Pursuant to Section 54.1-2400(10) of the Code, Ms. Campbell may, not later than 5:00 p.m., on June 3, 2016, notify Jay P. Douglas, M.S.M., R.N., C.S.A.C., F.R.E., Executive Director, Board of Nursing, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in writing that she desires a formal administrative hearing before the Board. Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated.
