Dear Ms. Campbell:

This is official notification that an informal conference will be held pursuant to §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), on April 5, 2016, at 2:00 p.m., at the Department of Health Professions, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia 23233. You may be represented by an attorney at the conference. This informal conference will be convened as a public meeting pursuant to § 2.2-3700 et seq. of the Code.

The Special Conference Committee ("Committee"), which is comprised of at least two members of the Virginia Board of Nursing ("Board"), will receive and act upon your application for the reinstatement of your registration to practice as a medication aide in the Commonwealth of Virginia, which was suspended by an Order of the Board entered May 27, 2015, and will inquire into allegations that you may have violated certain laws and regulations governing medication aide practice in Virginia.

Specifically:

1. You may have violated § 54.1-3007(1) of the Code and 18 VAC 90-60-120(1)(b) of the Regulations Governing the Registration of Medication Aides ("Regulations") in that on the application for reinstatement dated September 19, 2015, when asked to list all places where you have performed medication aide related duties for pay, you failed to disclose your employment at Ashland Nursing and Rehabilitation, which began on August 24, 2015, and your employment at Senior Healthcare Solutions, which began on January 25, 2015.

- 2. You may have violated § 54.1-3007(2) of the Code and 18 VAC 90-60-120(2)(e) of the Regulations in that:
- a. You falsified the employment application with Ashland Nursing and Rehabilitation dated August 17, 2015, in that you failed to disclose your employment with Senior Healthcare Solutions.
- b. You falsified the employment application with Senior Healthcare Solutions dated July 11, 2014, in that you failed to disclose your termination from Beth Shalom Nursing Home.

The burden rests on you to demonstrate that you are prepared to resume safe and competent practice as a medication aide.

After the informal conference, the Committee is authorized by $\S 54.1-2400(10)$ of the Code to take any of the following actions:

- The Committee may reinstate your registration to practice as a medication aide in the Commonwealth without restriction;
- The Committee may reinstate your registration and place you on probation for such time as it may designate and subject to such terms and conditions as it may deem appropriate, reprimand you, or impose a monetary penalty; or
 - The Committee may deny your application for reinstatement of your registration.

Further, the Committee may refer the case to the Board of Nursing or a panel thereof for a formal hearing.

If you fail to appear at the informal conference, the Committee may proceed to hear the case in your absence and may take any of the actions outlined above. At least ten days prior to the scheduled date of the conference, please inform this office at (804) 367-4515, or in writing at the address listed above, of your telephone number and whether you intend to appear at the informal conference.

To facilitate this proceeding, you should submit five copies of any documents you wish the Committee to consider to the Department of Health Professions, Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, by March 28, 2016. Your documents may not be submitted by facsimile or email.

You have the right to the information on which the Board will rely in making its decision. Therefore, I have enclosed a copy of the documents that will be distributed to the members of the Committee and will be considered by the Committee when discussing any allegations with you and when deliberating on your case. These documents are enclosed <u>only</u> with the original notice sent by certified mail, which you may be required to claim at the post office. Please bring these documents with you to the informal conference.
