**CONSENT ORDER**

The Virginia Board of Nursing ("Board") and Lisa Cederlund Sauer, R.N., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Cederlund Sauer's license to practice professional nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

**FINDINGS OF FACT**

1. Lisa Cederlund Sauer, R.N. was issued License No. 0001-257674 to practice professional nursing by the Virginia Board of Nursing on April 13, 2015. Said license is valid in Virginia only and is set to expire on September 30, 2017. Her primary state of residence is New York. She is also licensed as a professional nurse in the State of New York.
2. During the course of her employment as a professional nurse at Henrico Doctors' Hospital, Richmond, Virginia, Ms. Cederlund Sauer practiced as a professional nurse from January 5, 2015 to April 13, 2015, before receiving a license to practice.
3. Upon discovering she was unlicensed, Ms. Cederlund Sauer was sent home from work until she was licensed to practice in Virginia.

**CONCLUSIONS OF LAW**

The Board concludes that Finding of Fact No. 2 constitutes a violation of §§ 54.1-3007(3) and 54.1-3008(A)(2) of the Code of Virginia (1950), as amended ("Code").

CONSENT

Lisa Cederlund Sauer, R.N., by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her right to practice professional nursing in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. Ms. Cederlund Sauer shall pay a MONETARY PENALTY of Three Hundred Dollars (\$300.00) to the Board within 90 days of the entry of this Order.
2. Ms. Cederlund Sauer shall maintain a course of conduct in her capacity as a professional nurse commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

3. Any violation of the terms and conditions of this Order or of any law or regulation affecting the practice of nursing in the Commonwealth of Virginia shall constitute grounds for the suspension or revocation of the license of Lisa Cederlund Sauer, R.N. and an administrative proceeding shall be convened to determine whether such license shall be suspended or revoked.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
