<u>ORDER</u>

Pursuant to §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), a Special Conference Committee ("Committee") of the Virginia Board of Nursing ("Board") met on April 7, 2016 in Henrico County, Virginia, to inquire into evidence that Courtney J. Sickafoose, L.P.N. may have violated certain laws and regulations governing the practice of nursing in Virginia. Ms. Sickafoose was present and was not represented by legal counsel.

Upon consideration of the evidence, the Committee adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Courtney Sickafoose, L.P.N. was issued License No. 0002-089351 to practice practical nursing in the Commonwealth of Virginia on July 18, 2013. Said license is scheduled to expire on October 31, 2017. Her primary state of residence is Virginia.

- 2. By letter dated March 9, 2016, the Board of Nursing sent a Notice of Informal Conference ("Notice") to Ms. Sickafoose notifying her that an informal conference would be held on April 7, 2016. The Notice was sent by certified and first class mail to 2 Morrison Avenue, Newport News, Virginia 23601, the address of record on file with the Board of Nursing.
- 3. During the course of her employment with American Addiction Treatment Center, Newport News, Virginia, between August and September, 2015, Ms. Sickafoose diverted methadone, as evidenced by the following:

- a. She failed to have a witness cosign seven medication variance reports when she documented that she spilled methadone during the transfer from bulk bottles to patient dose bottles.
- b. She experienced far more incidents of methadone spillage than any other nurse at the facility.
- c. On August 14, 2015, she appeared impaired, in that she was described as "zoning out," "looking high," lethargic, having glassy eyes, and picking at her skin.
- d. On August 19, 2015, she documented spilling approximately 150 mg of methadone while filling Patient A's two take-home bottles of 80 mg each, when, in fact, the patient's prescribed dose was 110 mg, and she documented dispensing two 110 mg bottles as prescribed.
- e. On September 2, 2015, she tested positive for methadone, for which she did not have a prescription.
- 4. During the course of her employment at The Chesapeake, Newport News, Virginia, in May 2015, Ms. Sickafoose diverted hydrocodone (C-II) and diazepam (C-IV) for her personal and unauthorized use, as evidenced by the following:
- a. On May 19, 2015, she removed Resident B's diazepam and controlled medication utilization record from the medication cart after it had been discontinued. She falsely documented wasting the medication and failed to have another nurse witness the waste.
- b. On June 2, 2015, she tested positive for diazepam, for which she did not have a prescription.
- c. On May 28, 2015, she discontinued Resident B's hydrocodone without a physician's order. She removed this medication and controlled medication utilization record from the medication cart. She then falsely documented wasting the medication and falsified the initials of the other nurse who purportedly witnessed the waste.

- 5. At the informal conference, Ms. Sickafoose denied diverting the medications and stated that any discrepancies were due to documentation errors. She did not have an explanation for the fact that she tested positive for methadone and diazepam.
- 6. Ms. Sickafoose's employment with American Addiction Treatment Center was terminated on September 8, 2015. Her employment with The Chesapeake was terminated on June 10, 2015.
- 7. Ms. Sickafoose provided false information on an application for employment with Newport News Nursing and Rehabilitation, dated September 9, 2015:
  - a. She failed to list her employment with American Addiction and Treatment Center.
- b. She stated that her reason for leaving The Chesapeake was "did not feel that this was where [she] wanted to be," when, in fact, her employment had been terminated due to her failure to follow drug handling protocols and testing positive for substances for which she did not have a prescription.

## **CONCLUSIONS OF LAW**

- 1. Findings of Fact Nos. 3 and 4 constitute a violation of § 54.1-3007(2), (5), and (6) of the Code and 18 VAC 90-20-300(A)(2)(c) and (e) of the Regulations Governing the Practice of Nursing ("Regulations").
- 2. Finding of Fact No. 7 constitutes a violation of § 54.1-3007(2) of the Code and 18 VAC 90-20-300(A)(2)(e) of the Regulations.

### <u>ORDER</u>

On the basis of the foregoing, the Committee hereby ORDERS as follows:

Courtney Sickafoose, L.P.N. is hereby REPRIMANDED.

- 2. Ms. Sickafoose shall have an evaluation by a chemical dependency specialist satisfactory to the Board and shall have a written report of the evaluation, including a diagnosis, recommended course of therapy, prognosis, and any recommendations sent to the Board within 90 days after the date that this Order is entered. Upon receipt of the required information, the Board may request that Ms. Sickafoose reappear before a Special Conference Committee in order to consider the specialist's recommendations and to make a final disposition of the matter.
- 3. Ms. Sickafoose shall maintain a course of conduct in her capacity as a practical nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.
- 4. Any violation of the terms and conditions of this Order or of any law or regulation affecting the practice of nursing in the Commonwealth of Virginia shall constitute grounds for the suspension or revocation of the license of Ms. Sickafoose, and an administrative proceeding shall be convened to determine whether such license shall be suspended or revoked.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying on request.

Pursuant to Section 54.1-2400(10) of the Code, Ms. Sickafoose may, not later than 5:00 p.m., on May 23, 2016, notify Jay P. Douglas, M.S.M., R.N., C.S.A.C., F.R.E., Executive Director, Board of Nursing, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in writing that she desires a formal administrative hearing before the Board. Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated.
