NOTICE OF INFORMAL CONFERENCE BEFORE AN AGENCY SUBORDINATE

Dear Ms. Carey:

This letter is official notification that an informal conference of the Virginia Board of Nursing ("Board") will be held on **January 12**, **2016**, at **1:00 p.m.**, at the Department of Health Professions, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia. In accordance with §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), this informal conference will be held before an agency subordinate of the Board of Nursing. This informal conference will be convened as a public meeting pursuant to § 2.2-3700 et seq. of the Code. The agency subordinate will inquire into allegations that you may have violated certain laws and regulations governing practical nursing practice in Virginia.

Specifically:

- 1. During the course of your employment at Sentara Woodview Assisted Living Facility, South Boston, Virginia:
- a. You may have violated § 54.1-3007(2), (5) and (6) of the Code and 18 VAC 90-20-300(A)(2)(c) and (e) of the Regulations Governing the Practice of Nursing ("Regulations") in that on or about May 20, 2015, you diverted Lortab tablets (hydrocodone, C-II) for your personal and unauthorized use. You also removed the narcotic count sheet and falsely documented that the drugs were removed for destruction.

- b. You may have violated § 54.1-3007(5) and (6) of the Code in that on or about May 22, 2015, on a reasonable cause drug screen, you tested positive for benzodiazepines, cocaine, opiates and tetrahydrocannabinol, for which you did not have valid prescriptions.
- 2. You may have violated § 54.1-3007(2), (5), and (8) of the Code and 18 VAC 90-20-300(A)(2)(c) and (f) of the Regulations in that during the course of your employment at Senior Citizens Home, Inc., Henderson, North Carolina, on or about October 31, 2014, you removed resident's prescriptions and medications from the pharmacy return box, for your personal and unauthorized use.
- 3. You may have violated §§ 54.1-3007(3), 54.1-3008(2) and 54.1-3011(C) of the Code in that after your license to practice practical nursing expired on or about April 30, 2014, you practiced nursing at Senior Citizens Home, Inc., from May 1, 2014 to November 4, 2014, without a valid license.
- 4. You may have violated § 54.1-3007(2) and (5) of the Code and 18 VAC 90-20-300(A)(2)(e) of the Regulations in that:
- a. On the employment application with Sentara Woodview dated April 12, 2015, you falsely indicated that you left your employment at Senior Citizens Home, Inc., due to relocation, when, in fact, your employment was terminated on November 4, 2014.
- b. On the employment applications with Senior Citizens Home, Inc., dated February 21, 2013, and Halifax Regional Health System dated May 23, 2007, you answered "no" to the questions "have you ever been convicted of a crime," when, in fact, you have several convictions as indicated below.
- 5. You may have violated § 54.1-3007(4) of the Code in that on or about January 27, 1999, in the District Court of Granville County, North Carolina, you were convicted of larceny and possession of stolen goods/property, both misdemeanors involving moral turpitude.

In its deliberations, the agency subordinate may use the Sanction Reference Points System, as contained in the Sanction Reference Manual. The manual, which is a guidance document of the Board, may be accessed at http://www.dhp.virginia.gov/nursing. Please click on *Guidance Documents*, then select #90-7. You may also request a paper copy from the Board office by calling (804) 367-4515.

After consideration of all information, the agency subordinate may:

- If the agency subordinate finds that there is insufficient evidence to warrant further action or that the charges are without foundation, notify you by mail that your record has been cleared of any charge which might affect your right to practice nursing in the Commonwealth;
- Recommend findings of fact, conclusions of law and a sanction, to include a reprimand, placing you on probation with terms, suspension or revocation of your license, or imposing a monetary penalty pursuant to § 54.1-2401 of the Code.

Further, the agency subordinate may refer this matter for a formal administrative proceeding pursuant to § 2.2-4020 of the Code.

Since the allegations listed above involve impairment, please be advised that you may make application to the Health Practitioners' Monitoring Program ("HPMP"), which is available to all health care practitioners licensed in Virginia. Information about the HPMP is enclosed. Should you enter into a written agreement with the HPMP prior to your informal conference, the agency subordinate will take that into consideration when making a recommendation in your case.

Board's Review of Agency Subordinate's Recommended Decision

If you appear in person or by counsel at the informal conference, the recommendation of the agency subordinate will be presented to a panel of the Board. The Board may accept or modify the recommendation, or reject the recommendation and move the case to formal hearing. If you do not agree with the decision of the Board, you have the right to a formal administrative hearing before the Board.

If you fail to appear in person or by counsel at the informal conference, the recommendation of the agency subordinate will be presented to a panel of the Board. The Board may accept or modify the recommendation, or reject the recommendation. The Board's decision regarding the agency subordinate's recommendation is a final order that can only be appealed to circuit court as provided by Rule 2A:2 of the Supreme Court of Virginia.

You have the right to information that will be relied upon by the agency subordinate in making a decision. Therefore, I enclose a copy of the documents that will be distributed to the agency subordinate, and will be considered when discussing the allegations with you and when deliberating upon your case. These documents are enclosed only with the original notice sent by certified mail, which you may be required to claim at the post office. Please bring these documents with you to the informal conference.

To facilitate this proceeding, you should submit five copies of any documents you wish the agency subordinate to consider to the Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 300, Richmond, VA 23233, by January 5, 2016. Your documents may not be submitted by facsimile or email.

You may be represented by an attorney at the informal conference. If you obtain counsel, you should do so as soon as possible, because absent good cause to support a request for a continuance, the informal conference will be held on January 12, 2016. A request to continue this proceeding must state in detail the reason for the request and must establish good cause. Such request must be made, in writing, to me at the address listed on this letter and must be received by 12 noon on January 5, 2016. Only one such motion will be considered. Absent critical circumstances, such as personal or family illness, a request for a continuance after January 5, 2016, will not be considered.
