CONSENT ORDER

The Virginia Board of Nursing ("Board") and Lisa M. Mason, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Mason's application for reinstatement of her certificate to practice as a nurse aide in the Commonwealth of Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Lisa M. Mason was issued Certificate No. 1401-139393 to practice as a nurse aide by the Virginia Board of Nursing on August 20, 2010. Said certificate expired on August 31, 2012.
2. Ms. Mason submitted an application for reinstatement of her certificate which was received by the Board on December 8, 2015.
3. Ms. Mason has been convicted of the following crimes:
 - a. In the Circuit Court for the City of Danville, Virginia:
 - i. On May 18, 2012, she was convicted of one count of failure to return rental property, a felony. She was sentenced on June 28, 2012, to four years incarceration, with three years and eight months suspended on the condition that she keep the peace and be of good behavior for three years; she was sentenced to 18 months supervised probation and ordered to pay restitution and fines. She was successfully released from the terms of her probation on April 12, 2015.
 - ii. On January 6, 1998, she was convicted of one count of petit larceny, a misdemeanor involving moral turpitude. She was ordered to pay fines and costs.
 - b. On May 11, 2012, she was convicted in the General District Court for the City of Danville, Virginia, of one count of shoplifting, a misdemeanor involving moral turpitude. She was sentenced to 120 days incarceration with 100 days suspended and was ordered to pay fines and costs.

4. Ms. Mason has paid all fines, costs and restitution.

CONCLUSIONS OF LAW

The Board concludes that:

1. Finding of Fact No. 3 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").
2. Ms. Mason otherwise meets the requirements for reinstatement of her certificate to practice as a nurse aide.

CONSENT

Lisa M. Mason, by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. She consents to the entry of the following Consent Order affecting her application for the reinstatement of her certificate to practice as a nurse aide in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Consent Order, and in lieu of further proceedings, hereby ORDERS as follows:


1. The application of Lisa M. Mason for reinstatement of her certificate to practice as a nurse aide is hereby APPROVED. The Board shall issue Ms. Mason an unrestricted certificate to practice as a nurse aide in the Commonwealth of Virginia.

2. Ms. Mason is hereby REPRIMANDED.

3. Ms. Mason shall maintain a course of conduct in her capacity as a nurse aide commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.




