NOTICE OF INFORMAL CONFERENCE

Dear Ms. Springer:

This is official notification that an informal conference will be held pursuant to §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), on February 18, 2016, at 1:00 p.m., at the Department of Health Professions, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia 23233. You may be represented by an attorney at the conference. This informal conference will be convened as a public meeting pursuant to § 2.2-3700 et seq. of the Code.

The Special Conference Committee ("Committee"), which is comprised of at least two members of the Virginia Board of Nursing ("Board"), will inquire into allegations that you may have violated certain laws and regulations governing nursing practice in Virginia.

Specifically, you may have violated § 54.1-3007(2), (5) and (8) of the Code and 18 VAC 90-20-300(A)(2)(e) and (f) of the Regulations Governing the Practice of Nursing in that on or about March 18, 2015, during the course of your employment with the Laurels of Willow Creek, Midlothian, Virginia, you failed to administer the following medications to the following residents during your morning medication pass, and disposed of those medications in the medication cart trash can. Further, you falsely documented administering these medications in the residents' Medication Administration Records.

1. Resident A: Digoxin 0.125mg (C-VI) and Sinemet 25/100mg (C-VI).

- 2. Resident B: Carvedilol 12.5 mg (C-VI), Zoloft 200mg (C-VI), Bumex 1mg (C-VI), Valsartan 80mg (C-VI), Primidone 250mg (C-VI) and Reglan 5mg (C-VI).
 - 3. Resident C: Aricept 5mg (C-VI), Namenda XR 14mg (C-VI), and her multivitamin.
- 4. Resident D: Atenolol 25mg (C-VI), Thiamine (C-VI), Vitamin D, Seroquel (C-VI) and Keppra C-VI).

Please see Attachment I for the names of the residents referred to above.

In its deliberations, the Committee may use the Sanction Reference Points System, as contained in the Sanction Reference Manual. The manual, which is a guidance document of the Board, may be accessed at http://www.dhp.virginia.gov/nursing. Please click on *Guidance Documents*, then select #90-7. You may also request a paper copy from the Board office by calling (804) 367-4515.

After the informal conference, the Committee is authorized by § 54.1-2400(10) of the Code to take any of the following actions:

- If the Committee finds that there is insufficient evidence to warrant further action or that the charges are without foundation, the Committee shall notify you by mail that your record has been cleared of any charge which might affect your right to practice nursing in the Commonwealth;
 - The Committee may reprimand you;
- The Committee may place you on probation for such time as it may designate and subject to such terms and conditions as it may deem appropriate; or
 - The Committee may impose a monetary penalty.

Further, the Committee may refer the case to the Board of Nursing or a panel thereof for a formal hearing. If the Committee is of the opinion that suspension or revocation may be justified, the Committee may offer you a Consent Order for suspension or revocation in lieu of a formal hearing.

If you fail to appear at the informal conference, the Committee may proceed to hear the case in your absence and may take any of the actions outlined above. At least ten days prior to the scheduled date of the conference, please inform this office at (804) 367-4515, or in writing at the address listed above, of your telephone number and whether you intend to appear at the informal conference.

To facilitate this proceeding, you should submit five copies of any documents you wish the Committee to consider to the Department of Health Professions, Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, by February 11, 2016. Your documents may not be submitted by facsimile or email.

You have the right to the information on which the Board will rely in making its decision. Therefore, I have enclosed a copy of the documents that will be distributed to the members of the Committee and will be considered by the Committee when discussing any allegations with you and when deliberating on your case.
