**ORDER** 

The Virginia Board of Nursing ("Board") adopts the following Findings of Fact and Conclusions of Law and issues this Order affecting the license of Dennis M. Bullen, R.N., to practice as a professional nurse in Virginia.

**FINDINGS OF FACT** 

1. Dennis M. Bullen, R.N., was issued License No. 0001-229444 to practice professional nursing by the Virginia Board of Nursing on February 23, 2011. Said license is set to expire on December 31, 2016. Mr. Bullen's primary state of residence is Ohio. Mr. Bullen holds License No. 205425 to practice as a professional nurse and Certificate No. COA-02041 to practice as a nurse anesthetist in the state of Ohio. He also holds License No. 47040257996 to practice as a professional nurse in the state of Michigan and License No. RN562024 to practice as a professional nurse in the Commonwealth of Pennsylvania.

- 2. By Order of the Board entered on November 5, 2014, the Board placed Mr. Bullen on probation with terms and conditions and until such time as he successfully completed the terms of his probation with the Ohio Board of Nursing.
  - 3. The Ohio Board of Nursing released Mr. Bullen from probation on November 23, 2015.
- 4. Mr. Bullen submitted a petition for release from probation with the Virginia Board of Nursing on December 1, 2015.
  - 5. Mr. Bullen has complied with all terms and conditions of probation.

**CONCLUSIONS OF LAW**

Mr. Bullen shall maintain a course of conduct in his capacity as a professional nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.
