Dear Ms. Grant:

This is official notification that an informal conference will be held pursuant to §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), on February 3, 2010, at 9:00 a.m., at the Department of Health Professions, Perimeter Center, 9960 Mayland Drive, Suite 201, Richmond, Virginia 23233. You may be represented by an attorney at the conference. This informal conference will be convened as a public meeting pursuant to § 2.2-3700 et seq. of the Code.

The Special Conference Committee ("Committee"), which is comprised of at least two members of the Virginia Board of Nursing ("Board"), will inquire into allegations that you may have violated certain laws and regulations governing practical nursing practice in Virginia.

Specifically, between September, 2008, and April, 2009, during the course of your employment with Visions Community Services, Virginia Beach, Virginia, while contracted to provide care to Patient A in your home:

- 1. You may have violated § 54.1-3007(2), (5) and (8) of the Code and 18 VAC 90-20-300(A)(2)(f) of the Regulations Governing the Practice of Nursing ("Regulations") in that you neglected the patient's medical and physical care, as evidenced by the following:
 - a. You failed to transport Patient A to chemotherapy and other medical appointments.
- b. You gave Patient A ice cream and other food despite an order that he receive nothing by mouth, and after he was allowed to eat soft food, you gave him candy, hot dogs, and other foods that could cause him to choke.

- c. You failed to recognize Patient A's symptoms of aspiration pneumonia in February, 2009.
- d. You failed to recognize that Patient A was suffering from a fever on or about March 20, 2009, and you failed to make an appointment for him with his primary care physician when this was pointed out to you.
- e. You failed to recognize that Patient A was suffering with a fever, thrush, and cellulitis on or about April 1, 2009.
 - f. You failed to maintain Patient A's tracheotomy tube in a clean and sterile condition.
 - g. You failed to maintain Patient A's personal hygiene.
- h. You failed to ensure that Patient A had appropriate care when he visited overnight with his family.
 - i. You failed to ensure that Patient A had appropriate care when you were ill.
 - j. You failed to complete and submit daily nursing assessments and other documentation.
- k. You failed to accurately document the administration of medications to Patient A on his Medication Administration Records.
- 2. You may have violated § 54.1-3007(2), (5), and (8) of the Code and 18 VAC 90-20-300(A)(2)(k) and (1) of the Regulations in that you bought cigarettes and food items for yourself with Patient A's funds and you allowed Patient A to pay for your movie tickets.

In its deliberations, the Committee may use the Sanction Reference Points System, as contained in the Sanction Reference Manual. The manual, which is a guidance document of the Board, may be accessed at http://www.dhp.virginia.gov/nursing. Please click on *Guidance Documents*, then select #90-7. You may also request a paper copy from the Board office by calling (804) 367-4515.

After the informal conference, the Committee is authorized by § 54.1-2400(10) of the Code to take any of the following actions:

- If the Committee finds that there is insufficient evidence to warrant further action or that the charges are without foundation, the Committee shall notify you by mail that your record has been cleared of any charge which might affect your right to practice nursing in the Commonwealth;
- The Committee may place you on probation for such time as it may designate and subject to such terms and conditions as it may deem appropriate; Stephanie Grant, L.P.N.

- The Committee may reprimand you; or
- The Committee may impose a monetary penalty.

Further, the Committee may refer the case to the Board of Nursing or a panel thereof for a formal hearing. If the Committee is of the opinion that suspension or revocation may be justified, the Committee may offer you a Consent Order for suspension or revocation in lieu of a formal hearing.

If you fail to appear at the informal conference, the Committee may proceed to hear the case in your absence and may take any of the actions outlined above. At least ten days prior to the scheduled date of the conference, please inform this office at (804) 367-4515, or in writing at the address listed above, of your telephone number and whether you intend to appear at the informal conference.

To facilitate this proceeding, you should submit five copies of any documents you wish the Committee to consider to the Department of Health Professions, Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 300, Richmond, Virginia 23233, by January 27, 2010. Your documents may not be submitted by facsimile or email.

You have the right to the information on which the Board will rely in making its decision. Therefore, I have enclosed a copy of the documents that will be distributed to the members of the Committee and will be considered by the Committee when discussing any allegations with you and when deliberating on your case. These documents are enclosed only with the original notice sent by certified mail, which you may be required to claim at the post office. Please bring these documents with you to the informal conference.

Relevant sections of the Administrative Process Act, which govern proceedings of this nature, as well as laws relating to the practice of nursing and other healing arts in Virginia cited in this notice, can be found on the Internet at http://legl.state.va.us. To access this information, please click on the *Code of Virginia* for statutes and *Virginia Administrative Code* for regulations.

In the event of inclement weather, please be advised that Board of Nursing hearings will be held unless state offices are closed. Please listen to television or radio announcements to provide information about official state closings or delays. If there is a delayed opening, hearings will begin at the time of the agency opening.
