CONSENT ORDER

The Virginia Board of Nursing, and Kelly Supplee, R.N., with her consent as evidenced by her signature below, enter into the following Consent Order affecting Ms. Supplee's license to practice professional nursing in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Kelly Supplee, R.N., currently holds License No. 0001-175854 issued by the Virginia Board of Nursing ("Board").
2. By Order of the Board entered March 18, 2005, the Board took no action against Ms. Supplee's license contingent upon her compliance with certain terms and conditions, to include her compliance with a Recovery Monitoring Contract with the Health Practitioners' Intervention Program ("HPIP"), pursuant to Chapter 25.1 of Title 54.1 of the Code of Virginia (1950) as amended ("Code"), and 18 VAC 76-10-10, et seq., of the Regulations Governing the HPIP. Ms. Supplee violated Terms No. 1 and 2(a) of the Board's Order, in that, she resigned from HPIP, effective June 29, 2005.

CONSENT

Kelly Supplee, R.N., by affixing her signature hereon, agrees to the following:

1. Ms. Supplee acknowledges that she has been specifically advised to seek advice of counsel prior to signing this document;
2. Ms. Supplee acknowledges that she is fully aware that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000.A et seq., of the Code of Virginia (1950), as amended;
3. Ms. Supplee acknowledges that she has the following rights among others: the right to an informal fact finding conference before the Board, to reasonable notice of said administrative

proceeding, to representation by counsel, and the right to present witnesses and evidence on her behalf;

4. Ms. Supplee waives all such right to an informal conference;

5. Ms. Supplee admits to the above Findings of Fact;

6. Ms. Supplee consents to the entry of the following Order affecting her practice of professional nursing in the Commonwealth of Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Consent Order, hereby ACCEPTS the SURRENDER for INDEFINITE SUSPENSION of the license of Kelly Supplee, R.N., in lieu of further administrative proceedings in this matter. At such time as Ms. Supplee shall petition the Board for reinstatement of her license, an administrative proceeding will be convened to receive evidence satisfactory to the Board that she is capable of resuming the safe and competent practice of nursing.

Upon entry of this Consent Order, the license of Kelly Supplee, R.N., will be recorded as suspended and no longer current. Consistent with the terms of this Consent Order, in the event that Ms. Supplee seeks reinstatement of her license, she shall be responsible for any fees that may be required for the reinstatement and renewal of her license prior to issuance of her license to resume practice.

Pursuant to Sections 2.2-4023 and 54.1-2400.2 of the Code of Virginia (1950), as amended, the signed original of this Consent Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying on request.
