Dear Ms. Proveaux:

Pursuant to Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), you are hereby given notice that your license to practice nursing in the Commonwealth of Virginia has been mandatorily suspended by the enclosed Order entered December 17, 2015. You are hereby advised that, pursuant to Section 54.1-2409.1 of the Code, any person who practices a profession or occupation after having their license or certificate to do so suspended shall be guilty of a felony. Please return your license to Jay P. Douglas, Executive Director of the Virginia Board of Nursing, at the above address, immediately upon receipt of this letter.

Section 54.1-2409 of the Code further provides that you may apply to the Board of Nursing ("Board") for reinstatement of your license, and shall be entitled to a hearing not later than the next regular meeting of the Board after the expiration of sixty days from the receipt of such reinstatement application. You have the following rights, among others: to be represented by legal counsel, to have witnesses subpoenaed on your behalf, to present documentary evidence and to cross-examine adverse witnesses. The reinstatement of your license shall require the affirmative vote of three-fourths of the members present of the Board of Nursing.

ORDER

In accordance with Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), I, David E. Brown, D.C., Director of the Virginia Department of Health Professions, received and acted upon evidence that the Alaska Board of Nursing accepted the voluntary surrender, in lieu of further disciplinary action, from Cynthia Louise Bowen Proveaux, R.N., of her license to practice nursing in the State of Alaska by a Surrender of License Order dated October 22, 2015. A certified copy of the Surrender of a License Order is attached to this Order and is marked as Commonwealth's Exhibit No. 1.

WHEREFORE, by the authority vested in the Director of the Department of Health Professions pursuant to Section 54.1-2409 of the Code, it is hereby ORDERED that the privilege of Cynthia Louise Bowen Proveaux, R.N., to renew her license to practice nursing in the Commonwealth of Virginia be, and hereby is, SUSPENDED.

Upon entry of this Order, the license of Cynthia Louise Bowen Proveaux, R.N., will be recorded as suspended. Should Ms. Proveaux seek reinstatement of her license pursuant to Section 54.1-2409 of the Code, she shall be responsible for any fees that may be required for the reinstatement and renewal of her license prior to issuance of her license to resume practice.

Pursuant to Sections 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public inspection and copying upon request.

7 I, Cynthia Proveaux, voluntarily surrender my Alaska license # NUR R 30506, which
8 was first issued to me on August 24, 2009, and has an expiration date of November 30, 2016.

9 I am surrendering my above license at this time with the understanding that the Division
10 of Corporations, Business and Professional Licensing concluded an active investigation under
11 case number 2015-000684 on behalf of the Alaska Board of Nursing, which substantiated the
12 allegation of failing to disclose previous disciplinary action in another state on my 2012-2014
13 Registered Nurse – Biennial License Renewal application, a violation of AS 08.68.270(1).

14 I understand that as a result of this surrender, I cannot practice as a Registered Nurse in
15 the State of Alaska, and will not be able to do so until I have the approval of the Board of
16 Nursing. I further understand that before my license to practice as a Registered Nurse in Alaska
17 can be reinstated, I will have to prove to the above Board that I am competent to resume
18 practice, and am able to do so with skill and safety. If I make such request for reinstatement,
19 and I am denied by the Board of Nursing, I have the right to a Hearing, pursuant to AS 44.62, of
20 the Administrative Procedure Act.

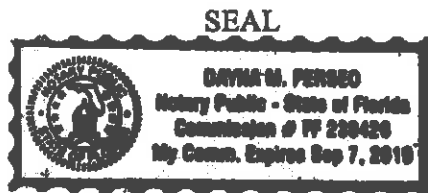
21 I am surrendering my license of my own free will. I am not under the influence of any

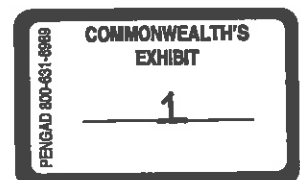
