actually received this decision or the date it was mailed to her, whichever occurred first) within which to appeal

REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Jane Elliott, R.N., Ph.D., serving as

Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal conference on

November 7, 2016 in Henrico County, Virginia, to inquire into evidence that Shann Kay Hartman,

R.N., may have violated certain laws and regulations governing the practice of professional nursing in

the Commonwealth of Virginia.

Ms. Hartman did not appear at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated October 7, 2016, the Board sent a Notice of Informal Conference ("Notice") to

Ms. Hartman notifying her that an informal conference would be held on November 7, 2016. The

Notice was sent by certified and first class mail to the legal address of record on file with the Board.

The certified mail receipt was signed and returned to the Board. The Notice sent by first class mail

was not returned to the Board office. Accordingly, the Agency Subordinate concluded that adequate

notice was provided to Ms. Hartman and the informal conference proceeded in her absence.

Recommended Findings of Fact and Conclusions of Law

- 1. Shann Kay Hartman, R.N., was issued License Number 0001-170473 to practice professional nursing on May 26, 2000, which is scheduled to expire on March 31, 2018. At all times relevant to the findings herein, said license was in full force and effect. Her primary state of residence is Virginia.
- 2. By Order of the Board entered December 15, 2015 ("Board's Order"), the Board took no action against Ms. Hartman contingent upon her entering the Health Practitioners' Monitoring Program ("HPMP") within 60 days of entry of the Order, due to findings of substance abuse and mental illness, for which she received diagnoses of mood disorder and borderline personality disorder.
- 3. Ms. Hartman violated Virginia Code § 54.1-3007(6) and Term No. 1 of the Board's Order in that she has not entered the HPMP.
- 4. On March 20, 2016, during an interview with an investigator from the Department of Health Professions, Ms. Hartman denied being an alcoholic and stated that she was not going to enter the HPMP.
- 5. Pursuant to Virginia Code § 54.1-2400.2(K), the Board considered whether to disclose or not disclose Ms. Hartman's health records or health services.

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate recommends that the Board issue an Order as follows:

- 1. Shann Kay Hartman, R.N., is REPRIMANDED.
- 2. The license issued to Shann Kay Hartman, R.N., to practice professional nursing in the Commonwealth of Virginia is INDEFINITELY SUSPENDED.
 - 3. The license of Shann Kay Hartman, R.N., will be recorded as SUSPENDED.

4. This suspension applies to any multistate privilege to practice professional nursing.

5. Should Shann Kay Hartman, R.N., seek reinstatement of her license, an administrative

proceeding shall be convened to consider such application. At such time, the burden shall be on Ms.

Hartman to demonstrate that she is safe and competent to return to the practice of professional nursing.

Ms. Hartman shall be responsible for any fees that may be required for the reinstatement and/or

renewal of the license prior to issuance of the license to resume practice.
