WHEREUPON, pursuant to its authority under § 54.1-2408.1(A) of the Code, the Board concludes that a

substantial danger to public health or safety warrants this action and ORDERS that the license of Pamela S.

Casella, R.N.., License No. 0001-107369, to practice professional nursing in the Commonwealth of Virginia is

hereby SUSPENDED. It is further ORDERED that a hearing be convened forthwith to receive and act upon

evidence in this case and that the Executive Director of the Board shall be authorized to execute this Order and

all other documents, notices and orders on behalf of the Board necessary to bring this matter to a hearing.

Upon entry of this Order, the certificate of Pamela S. Casella, R.N., will be recorded as suspended and

no longer current.

Pursuant to § 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the

Department of Health Professions as a public record and shall be made available for public inspection or

copying on request.

NOTICE OF HEARING

Pursuant to §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11) of the Code of Virginia (1950), as amended

("Code"), Pamela Casella, R.N., who, prior to its summary suspension by the Board of Nursing ("Board") on

December 10, 2015, held License No. 0001-107369 to practice professional nursing in Virginia, is hereby

given notice that a formal administrative hearing will be held in the presence of a panel of the Board. The

hearing will be held on January 25, 2016, at 9:00 a.m., at the offices of the Department of Health

Professions, Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia 23233,

at which time Ms. Casella will be afforded the opportunity to be heard in person or by counsel.

At the hearing, Ms. Casella has the following rights, among others: the right to representation by

counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to present

documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Casella desires any

witnesses to appear on her behalf, she must notify the Director of Administrative Proceedings, Department of

Health Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in accordance with the

Instructions for Requesting Subpoenas.

The purpose of the hearing is to inquire into evidence that Ms. Casella may have violated certain laws

governing professional nursing practice in Virginia as more fully set out in the Statement of Particulars

below.

STATEMENT OF PARTICULARS

The Board alleges that Pamela S. Casella, R.N., may be in violation of § 54.1-3007(6) of the Code in that she may be unable to safely practice nursing due to mental and/or physical illness, as evidenced by the following:

- 1. From on or about May 11, 2015, through on or about May 20, 2015, Ms. Casella was hospitalized at Southside Regional Medical Center pursuant to a temporary detention order and received inpatient psychiatric treatment. She was diagnosed with post-traumatic stress disorder.
- 2. From on or about June 7, 2015, through on or about July 9, 2015, Ms. Casella was hospitalized at Virginia Commonwealth University Medical Center following suicidal ideation and a suicide attempt. She was diagnosed with major depressive disorder, recurrent severe with psychotic features, post-traumatic stress disorder, and borderline personality disorder.
- 3. From on or about September 8, 2015, through on or about September 11, 2015, Ms. Casella was hospitalized at Tucker Pavilion, Richmond, Virginia, pursuant to a temporary detention order issued after she made threats of suicide. She was diagnosed with post-traumatic stress disorder, mood disorder, not otherwise specified, and personality disorder, not otherwise specified.
