**ORDER** 

Pursuant to §§ 2.2-4020, 54.1-110 and 54.1-2400(11) of the Code of Virginia (1950), as amended ("Code"), a formal administrative hearing was held before a panel of the Board of Nursing ("Board") on November 19, 2015, in Henrico County, Virginia, to inquire into evidence that Amanda Gibson, L.P.N., may have violated certain laws and regulations governing nursing practice in Virginia. The case was presented by Wendy Deaner, Adjudication Specialist, Administrative Proceedings Division. Charis Mitchell, Assistant Attorney General, was present as legal counsel for the Board. Ms. Gibson was not present and was not

Upon consideration of the evidence presented, the Board adopted the following Findings of Fact and Conclusions of Law.

represented by legal counsel. The proceedings were recorded by a certified court reporter.

## **FINDINGS OF FACT**

- Amanda Gibson, L.P.N., was issued License No. 0002-080380 to practice practical nursing in the Commonwealth of Virginia on June 1, 2009. Said license expired on September 30, 2015. Ms. Gibson's primary state of residence is Virginia.
- 2. Based upon the representations of Wendy Deaner, Adjudication Specialist, and Commonwealth's Exhibit No. 1, the Notice of Formal Hearing and Statement of Particulars, Allegation Summary Worksheet, and Affidavit of Mailing, the presiding officer ruled that adequate notice was provided to the respondent and the hearing proceeded in her absence.
- 3. During the course of her employment with Nurse Finders, Roanoke, Virginia, while on assignment at Augusta Nursing and Rehabilitation Center, Fishersville, Virginia, on September 14, 2014:

- a. Ms. Gibson documented that she had administered Xanax (alprazolam, C-IV) to Resident A at midnight; however, she failed to do so.
- b. Ms. Gibson documented that she had withdrawn one tablet of methadone (C-II) for Resident A at 0600 hours and that she had administered the medication to the resident; however, she failed to do so.
- c. Ms. Gibson documented that she had withdrawn two tablets of hydrocodone (C-II) for Resident B at 0200 hours and that she had administered the medication to the resident; however, she failed to do so.
- d. Ms. Gibson documented that she had withdrawn one tablet of oxycodone (C-II) for Resident C at 0200 hours and that she had administered the medication to the resident; however, she failed to do so.
- e. Ms. Gibson documented that she had administered two tablets of acetaminophen at 0600 hours and one tablet of levothyroxine at 0630 hours to Resident D; however, she failed to do so.
- 4. Ms. Gibson's employment with Nurse Finders was inactivated due to her lack of cooperation during their investigation of the above medication administration discrepancies.

## **CONCLUSIONS OF LAW**

The Board concludes that Findings of Fact Nos. 3(a), (b), (c), (d), and (e) constitute a violation of §54.1-3007(2), (5) and (8) of the Code and 18 VAC 90-20-300(A)(2)(c), (e) and (f) of the Regulations Governing the Practice of Nursing.

## <u>ORDER</u>

WHEREFORE, the Virginia Board of Nursing, effective upon entry of this Order, hereby ORDERS as follows:

1. The right of Amanda Gibson, L.P.N., to renew License No. 0002-080380 to practice practical nursing in the Commonwealth of Virginia is hereby INDEFINITELY SUSPENDED for a period of not less

than two years.

2. The License of Ms. Gibson will be recorded as SUSPENDED. Should Ms. Gibson seek reinstatement of her license consistent with this Order, she shall be responsible for any fees that may be

required for the reinstatement of her license prior to issuance of her license to resume practice.

3. At such time as Ms. Gibson shall petition the Board for reinstatement of her license, an

administrative proceeding will be convened to determine whether she is able to return to the safe and competent

practice of practical nursing.

4. This Order shall be applicable to Ms. Gibson's multistate licensure privileges, if any, to

practice practical nursing.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in

the custody of the Department of Health Professions as public record and shall be made available for public

inspection or copying on request.
