NOTICE OF HEARING

Pursuant to §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11) of the Code of Virginia (1950), as amended

("Code"), Lasone K. Cannon, L.P.N., who holds License No. 0002-088260 to practice practical nursing in

the Commonwealth of Virginia which is set to expire on November 30, 2016, is hereby given notice that a

formal administrative hearing will be held in the presence of a panel of the Board of Nursing. The hearing

will be held on November 19, 2015, at 10:00 a.m., at the offices of the Department of Health Professions,

Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia 23233, at which time

Ms. Cannon will be afforded the opportunity to be heard in person or by counsel.

At the hearing, Ms. Cannon has the following rights, among others: the right to representation by

counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to present

documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Cannon desires any

witnesses to appear on her behalf, she must notify the Director of Administrative Proceedings, Department of

Health Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in accordance with the

Instructions for Requesting Subpoenas.

The purpose of the hearing is to inquire into evidence that Lasone K. Cannon, L.P.N., may have

violated certain laws and regulations governing nursing practice in Virginia, as more fully set forth in the

Statement of Particulars below.

## STATEMENT OF PARTICULARS

The Board alleges that Lasone K. Cannon, L.P.N., may have violated § 54.1-3007(2), (5) and (6) of the Code and 18 VAC 90-20-300(A)(2)(a), (c) and (e) of the Regulations Governing the Practice of Nursing in that during the course of her employment with Bon Secours Gynecologic Oncology Specialists, Newport News, Virginia, on or about October 15, 2014, Ms. Cannon entered a prescription for Percocet (oxycodone, C-II) in her own electronic medication record, using the name of a physician in the practice, without that physician's knowledge or authorization. Further, Ms. Cannon forged the physician's signature on the printed prescription and presented it to the hospital pharmacy in an attempt to obtain 20 tablets of Percocet.
