## NOTICE OF INFORMAL CONFERENCE BEFORE AN AGENCY SUBORDINATE

This letter is official notification that an informal conference of the Virginia Board of Nursing ("Board") will be held on **August 25, 2015** at **10:30 a.m.**, at the Department of Health Professions, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia. In accordance with §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), this informal conference will be held before an agency subordinate of the Board of Nursing. This informal conference will be convened as a public meeting pursuant to § 2.2-3700 et seq. of the Code. The agency subordinate will inquire into allegations that you may have violated certain laws and regulations governing certified nurse aide practice in Virginia.

## Specifically:

- 1. You may have violated § 54.1-3007(6) of the Code in that you may be unsafe to practice as a nurse aide due to mental illness as evidenced by the following: from on or about January 4, 2015 until on or about January 7, 2015, you received inpatient treatment at Tucker Pavilion at CJW Medical Center, Richmond, Virginia for a diagnosis of major depressive disorder.
- 2. You may have violated § 54.1-3007(2) of the Code and 18 VAC 90-25-100(2)(d) of the Regulations Governing Certified Nurse Aides, in that you provided false information on the following employment applications:
- a. On your application for employment with Westport Health Care Center, LLC, Richmond, Virginia, dated February 27, 2015:

- i. When asked if you had ever been discharged from a position, you falsely answered "no." In fact, your employment had been terminated from positions at Our Lady of Hope, Richmond, Virginia ("OLOH"), on or about October 17, 2014 and from Beaufont Health and Rehabilitation Center, Richmond, Virginia ("Beaufont") on or about July 14, 2011.
- ii. You wrote "grandson needed me" as your reason for leaving OLOH, when your employment there had been terminated for poor customer service on or about October 17, 2014.
- b. On your application for employment with OLOH dated April 3, 2014, you failed to disclose your previous employment with Beaufont from January 6, 2010 through on or about July 14, 2011.
- c. On your application for employment with the Laurels dated October 28, 2014, you failed to disclose your previous employment with OLOH and with Beaufont.

In its deliberations, the agency subordinate may use the Sanction Reference Points System, as contained in the Sanction Reference Manual. The manual, which is a guidance document of the Board, may be accessed at <a href="http://www.dhp.virginia.gov/nursing">http://www.dhp.virginia.gov/nursing</a>. Please click on *Guidance Documents*, then select #90-7. You may also request a paper copy from the Board office by calling (804) 367-4514.

After consideration of all information, the agency subordinate may:

- If the agency subordinate finds that there is insufficient evidence to warrant further action or that the charges are without foundation, notify you by mail that your record has been cleared of any charge which might affect your right to as a nurse aide in the Commonwealth; or
- Recommend findings of fact, conclusions of law and a sanction, to include a reprimand, placing you on probation with terms, suspension or revocation of your certificate, or imposing a monetary penalty pursuant to § 54.1-2401 of the Code.

Further, the agency subordinate may refer this matter for a formal administrative proceeding pursuant to  $\S 2.2-4020$  of the Code.

Since the allegations listed above involve impairment, please be advised that you may make application to the Health Practitioners' Monitoring Program ("HPMP"), which is available to all health care practitioners licensed in Virginia. Information about the HPMP is enclosed. Should you enter into a written agreement with the HPMP prior to your informal conference, the agency subordinate will take that into consideration when making a recommendation in your case.

## Board's Review of Agency Subordinate's Recommended Decision

If you appear in person or by counsel at the informal conference, the recommendation of the agency subordinate will be presented to a quorum of the Board. The Board may accept or modify the recommendation, or reject the recommendation and move the case to formal hearing. If you do not agree with the decision of the Board, you have the right to a formal administrative hearing before the Board.

If you fail to appear in person or by counsel at the informal conference, the recommendation of the agency subordinate will be presented to a quorum of the Board. The Board may accept or modify the

recommendation, or reject the recommendation. The Board's decision regarding the agency subordinate's recommendation is a final order that can only be appealed to circuit court as provided by Rule 2A:2 of the Supreme Court of Virginia.

You have the right to information that will be relied upon by the agency subordinate in making a decision. Therefore, I enclose a copy of the documents that will be distributed to the agency subordinate, and will be considered when discussing the allegations with you and when deliberating upon your case. These documents are enclosed only with the original notice sent by certified mail, which you may be required to claim at the post office. Please bring these documents with you to the informal conference.

To facilitate this proceeding, you should submit five copies of any documents you wish the agency subordinate to consider to the Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 300, Richmond, VA 23233, by August 20, 2015. Your documents may not be submitted by facsimile or email.

You may be represented by an attorney at the informal conference. If you obtain counsel, you should do so as soon as possible, because absent good cause to support a request for a continuance, the informal conference will be held on August 25, 2015. A request to continue this proceeding must state **in detail** the reason for the request and must establish good cause. Such request must be made, in writing, to me at the address listed on this letter and must be received by 12 noon on August 20, 2015. Only one such motion will be considered. Absent critical circumstances, such as personal or family illness, a request for a continuance after August 20, 2015, will not be considered.
