CONSENT ORDER

The Virginia Board of Nursing ("Board") and Wandnella Y. Millner, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Millner's application for reinstatement of her certificate to practice as a nurse aide in the Commonwealth of Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Wandnella Y. Millner was issued Certificate No. 1401-148047 to practice as a nurse aide by the Virginia Board of Nursing on September 21, 2011. Said certificate expired on September 30, 2013.
2. Ms. Millner submitted an application for reinstatement of her certificate which was received by the Board on July 31, 2015.
3. On July 29, 2013, Ms. Millner was convicted in the General District Court for the City of Danville, Virginia, of one count of shoplifting, a misdemeanor involving moral turpitude. She was sentenced to 120 days incarceration with all time suspended, and ordered to pay fines and costs.
3. Ms. Millner paid all fines and costs on March 25, 2014.

CONCLUSIONS OF LAW

The Board concludes that:

1. Finding of Fact No. 3 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").
2. Ms. Millner otherwise meets the requirements for reinstatement of her certificate to practice as a nurse aide.

CONSENT

Wandnella Y. Millner, by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. She consents to the entry of the following Consent Order affecting her application for the reinstatement of her certificate to practice as a nurse aide in Virginia.

ORDER


WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Consent Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. The application of Wandnella Y. Millner for reinstatement of her certification to practice as a nurse aide is hereby APPROVED. The Board shall issue Ms. Millner an unrestricted certificate to practice as a nurse aide in the Commonwealth of Virginia.
2. Ms. Millner is hereby REPRIMANDED.
3. Ms. Millner shall maintain a course of conduct in her capacity as a nurse aide commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.


