Dear Ms. Fikes:

Pursuant to Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), you are hereby given notice that your license to practice nursing and your certification to practice as a certified nurse aide in the Commonwealth of Virginia have been mandatorily suspended by the enclosed Order entered October 13, 2015. You are hereby advised that, pursuant to Section 54.1-2409.1 of the Code, any person who practices a profession or occupation after having their license, registration or certificate to do so suspended shall be guilty of a felony. Please return your license and certificate to Jay P. Douglas, Executive Director of the Virginia Board of Nursing, at the above address, immediately upon receipt of this letter.

Section 54.1-2409 of the Code further provides that you may apply to the Board of Nursing ("Board") for reinstatement of your license or certificate, and shall be entitled to a hearing not later than the next regular meeting of the Board after the expiration of sixty days from the receipt of such reinstatement application. You have the following rights, among others: to be represented by legal counsel, to have witnesses subpoenaed on your behalf, to present documentary evidence and to cross-examine adverse witnesses. The reinstatement of your license or certificate shall require the affirmative vote of three-fourths of the members of the Board of Nursing present at the hearing.

COURT MET THIS DAY PURSUANT TO ADJOURNMENT. PRESENT AND PRESIDING HIS HONOR, MARTIN E COADY, JUDGE, DIVISION "F", JOSEPH OUBRE, ASSISTANT DISTRICT ATTORNEY, RODNEY J STRAIN, JR, SHERIFF AND MALISE PRIETO, CLERK OF COURT (Mark Baggett and Willie Cooper, Bailiffs and Karen Jenkins, Court Reporter)

STATE OF LOUISIANA VS MONIQUE RENEE FIKES

The defendant being present in open Court attended by her Counsel, DAVID F CRAIG, JR. The defendant, personally and through her Counsel, withdrew her previously entered plea of not guilty and entered a plea of guilty as charged under the provisions of ARTICLE 893; whereupon Court had the defendant sworn and questioned her as to her age and level of education, Court read the statute to the defendant and possible penalty for same, Court explained to the defendant her right to an attorney and/or Court appointed attorney, right to trial, right against self-incrimination, right to confront her accusers, right to cross examine State's witnesses, right to use subpoena power and the right to appeal if found guilty, if defendant cannot afford an attorney one will be appointed to represent her on the appeal, defendant waived rights, Court satisfied that the defendant understands her rights and the charge against her, State and Defense adopted pre-trial conference for the factual basis, Court finds that there is a factual basis in support of the charge, Court accepted the plea of guilty and the following sentence was imposed:

MONIQUE FIKES, having declared that she is 38 years of age and having plead guilty herein to R.S. 14:71 ISSUING WORTHLESS CHECKS, by issuing in exchange for something of value, with the intent to defraud, the following check(s) drawn on the Bank identified below, knowing at the time of issuance that there was not sufficient funds with said Bank for payment of the checks upon presentation: Name of Bank: CHASE BANK, Amount of Check: SEE BILL OF INFORMATION, Name of Merchant: SEE BILL OF INFORMATION, Court at this time under the provisions of Article 893 Code of Criminal Procedure defers imposition of sentence and places the defendant on probation for a period of TWO (2) years under the supervision of the Department of Public Safety and Corrections of the State of Louisiana, under the general conditions of probation that have been made a part of the minutes of this Court and with the special conditions as set forth, 1. defendant is to pay a fine of \$1000 and costs; 2. defendant is to pay restitution thru the District Attorney's Office; 3. defendant is to refrain from illegal activity; 4. defendant is to report to his probation officer as required; 5. defendant is to pay a monthly supervision fee, all special conditions to be under the direction of her probation officer.
