

Dear Ms. Lee:

Pursuant to Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), you are hereby given notice that your license to practice nursing in the Commonwealth of Virginia has been mandatorily suspended by the enclosed Order entered October 1, 2015. You are hereby advised that, pursuant to Section 54.1-2409.1 of the Code, any person who practices a profession or occupation after having their license or certificate to do so suspended shall be guilty of a felony. Please return your license to Jay P. Douglas, Executive Director of the Virginia Board of Nursing, at the above address, immediately upon receipt of this letter.

Section 54.1-2409 of the Code further provides that you may apply to the Board of Nursing ("Board") for reinstatement of your license, and shall be entitled to a hearing not later than the next regular meeting of the Board after the expiration of sixty days from the receipt of such reinstatement application. You have the following rights, among others: to be represented by legal counsel, to have witnesses subpoenaed on your behalf, to present documentary evidence and to cross-examine adverse witnesses. The reinstatement of your license shall require the affirmative vote of three-fourths of the members present of the Board of Nursing.

ORDER

In accordance with Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), I, David E. Brown, D.C., Director of the Virginia Department of Health Professions, received and acted upon evidence that the license of Linda Joyce Fisher Lee, R.N., to practice nursing in the State of Louisiana was suspended by an Order dated September 11, 2015. A certified copy of the Order is attached to this Order and is marked as Commonwealth's Exhibit No. 1.

WHEREFORE, by the authority vested in the Director of the Department of Health Professions pursuant to Section 54.1-2409 of the Code, it is hereby ORDERED that the license of Linda Joyce Fisher Lee, R.N., to practice nursing in the Commonwealth of Virginia be, and hereby is, SUSPENDED.

Upon entry of this Order, the license of Linda Joyce Fisher Lee, R.N., will be recorded as suspended and no longer current. Should Ms. Lee seek reinstatement of her license pursuant to Section 54.1-2409 of the Code, she shall be responsible for any fees that may be required for the reinstatement and renewal of her license prior to issuance of her license to resume practice.

Pursuant to Sections 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public inspection and copying upon request.



Dear Mrs. Lee:

The Louisiana State Board of Nursing received notification that on or about May 5, 2015, you signed an Agreed Order with the Texas Board of Nursing. The Order probated your license to practice as a Registered Nurse in Texas and you were issued a Warning with Stipulations for the following incidents:

- From January 8, 2013, through January 28, 2013, while employed with TaleMed, Loveland, Ohio, and on assignment with Conroe Regional Medical Center, Conroe, Texas, you withdrew Morphine, Hydrocodone, Hydromorphone and Alprazolam from the Acudose-RX Medication Dispensing System for patients, but failed to accurately and completely document the medication, including failing to scan the medications.
- On or about January 31, 2013, while employed with TaleMed, Loveland, Ohio, and on assignment with Conroe Regional Medical Center, Conroe, Texas, you administered Haloperidol (Haldol) to a patient instead of Droperidol as ordered by the physician. You failed to scan the medication prior to administering the medication to the patient.

You are herewith notified that, in accordance with the Rules of the Louisiana State Board of Nursing, particularly LAC 46:XLVII.3411.L, your Louisiana registered nurse license is automatically suspended until such time as the matter is cleared with the Texas Board of Nursing.

Therefore, your Louisiana RN license is suspended.

This will be reported to the National Practitioner Data Bank (NPDB) as 39, License Revocation, Suspension or Other Disciplinary Action Taken by a Federal, State or Local Licensing Authority.

NPDB Narrative: Respondent's Registered Nurse license was automatically suspended after Respondent's RN license with the Texas Board of Nursing was probated and Respondent was issued a warning with stipulations due to narcotic discrepancies and administering the wrong medication to a patient.

If you are able to show error in the staff's action then you must so notify the Board in writing within ten (10) days of this date. If no staff error is found, the staff action for Automatic Suspension of your Louisiana

Registered Nurse license will be considered by the Board for ratification at the next Board meeting on August 12, 2015.

If you can present evidence to the Board that your disciplinary matter with the Texas Board of Nursing has been resolved, you may request a hearing for the purpose of having the Board consider the reinstatement of your license.
