documentary evidence; and the right to cross-examine adverse witnesses. If Mr. Farrar desires any witnesses

STATEMENT OF PARTICULARS

The Board alleges that James P. Farrar, Jr., C.N.A., R.M.A., may have violated §54.1-3007(6) of the Code and Term No. 5(a) of the Board's Order entered May 31, 2013, which required his continued compliance with the Health Practitioners' Monitoring Program ("HPMP"), in that on or about May 15, 2015, he was dismissed from the HPMP for noncompliance, including failure to enter treatment as recommended, continued use of benzodiazepines, and failure to comply with the toxicology screening program.
