AMENDED NOTICE OF HEARING

Pursuant to §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11) of the Code of Virginia (1950), as amended ("Code"), Amanda Gallier, C.N.A., R.M.A., who holds Certificate No. 1401-144968 to practice as a nurse aide, which was indefinitely suspended by Order of the Board entered February 4, 2015, and Registration No. 0031-004961 to practice as a medication aide, which expired on September 30, 2013 and of which the right to renew was indefinitely suspended by Order of the Board entered February 4, 2015, is hereby given notice that a formal administrative hearing will be held in the presence of a panel of the Board of Nursing. The hearing will be held on March 23, 2016, at 2:00 p.m., at the offices of the Department of Health Professions, Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia 23233, at which time Ms. Gallier will be afforded the opportunity to be heard in person or by counsel.

At the hearing, Ms. Gallier has the following rights, among others: the right to representation by counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to present documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Gallier desires any witnesses to appear on her behalf, she must notify the Director of Administrative Proceedings, Department of Health Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in accordance with the Instructions for Requesting Subpoenas.

The purpose of the hearing is to inquire into evidence that Ms. Gallier may have violated certain laws governing the practice of nurse aides and medication aides and certain terms and conditions imposed on her

as set forth in the Orders of the Board entered on February 4, 2015, as more fully set forth in the Statement of Particulars below ("Board's Orders").

STATEMENT OF PARTICULARS

The Board alleges that Amanda Gallier C.N.A., R.M.A., may have violated § 54.1-3007(6) of the Code, Term No. 4(a) of the Board's 2015 Order regarding Ms. Gallier's registration to practice a medication aide, and Term No. 5(a) of the Board's 2015 Order regarding Ms. Gallier's certificate to practice as a nurse aide, both of which required Ms. Gallier to enter into the Health Practitioners' Monitoring Program and to comply with all terms and conditions of the HPMP for the period specified by the HPMP. Specifically, Ms. Gallier was dismissed from the HPMP on September 18, 2015, for noncompliance, including failure to enter and complete treatment as recommended and failure to comply with the toxicology screening program.
