CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Hawa K. Sesay, L.P.N., as evidenced by their signatures hereto, in lieu of proceeding to a formal administrative proceeding, enter into the following Consent Order affecting Ms. Sesay's license to practice practical nursing in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Hawa K. Sesay, L.P.N., was issued License Number 0002-067357 to practice practical nursing on October 14, 2003, which is scheduled to expire on August 31, 2017. Her primary state of residence is Virginia. The license was suspended pursuant to Virginia Code § 54.1-2409 by Order of the Virginia Department of Health Professions on September 20, 2016.
- 2. By Order of the Department of Health Professions entered March 27, 2015, the license of Ms. Sesay was suspended pursuant to Virginia Code § 54.1-2409 based on evidence that her license to practice nursing in the State of Georgia had been suspended. The Virginia Board of Nursing reinstated Ms. Sesay's license to practice practical nursing in Virginia contingent on certain conditions by Order entered August 2, 2015, and the Board issued an Order on March 2, 2016 granting Ms. Sesay an unrestricted license to practice practical nursing in Virginia.
- 3. On May 19, 2016, the Ohio Board of Nursing suspended Ms. Sesay's license to practice practical nursing based on the actions of the Georgia and Virginia Boards of Nursing. Pursuant to

Virginia Code § 54.1-2409, by Order of the Virginia Department of Health Professions on September 20, 2016, Ms. Sesay's license was suspended based on the suspension of her license to practice practical nursing in the State of Ohio.

4. The matter of reinstatement of Ms. Sesay's license to practice practical nursing in the Commonwealth of Virginia is properly before the Board.

CONSENT

Hawa K. Sesay, L.P.N., by affixing her signature to this Consent Order, agrees to the following:

- 1. I have been advised to seek advice of counsel prior to signing this document;
- 2. I am fully aware that without my consent, no legal action can be taken against me or my license except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to a formal administrative hearing before the Board; the right to representation by counsel; and the right to cross-examine witnesses against me;
 - 4. I waive all right to a formal hearing;
- 5. I admit to the Findings of Fact and Conclusion of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my right to practice practical nursing in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS that the license of Hawa K. Sesay, L.P.N., to practice practical nursing in the Commonwealth of Virginia is REINSTATED without restriction.

Pursuant to Virginia Code §§2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.

ORDER

On September 18, 2015, the Ohio Board of Nursing issued a Notice of Opportunity for Hearing to HAWA K. KARGBO, LPN, informing her that the Board intended to consider disciplinary action regarding MS. KARGBO's license to practice nursing as a licensed practical nurse in the State of Ohio, and that MS. KARGBO was entitled to a hearing if such hearing was requested within thirty (30) days of the mailing of said notice.

In accordance with Section 119.07, Ohio Revised Code, said notice was sent via certified mail, return receipt requested, to the address of record of MS. KARGBO. The notice was returned to the Board because MS. KARGBO failed to claim it. The Board sent the notice via ordinary mail and obtained a certificate of mailing on December 4, 2015. The notice has not been returned to the Board showing failure of delivery.

No hearing request has been received from MS. KARGBO and more than thirty (30) days have now elapsed since the mailing of the notice.

Upon consideration of the charges stated against HAWA K. KARGBO in the September 18, 2015 Notice of Opportunity for Hearing and evidence supporting the charges, the Board finds that MS. KARGBO has committed acts in violation of the Nurse Practice Act, Ohio Revised Code Chapter 4723, as stated in the Notice of Opportunity for Hearing, and the Ohio Board of Nursing ORDERS that MS. KARGBO's license to practice nursing as a licensed practical nurse is hereby suspended for an indefinite period of time with the conditions for reinstatement set forth below.

REQUIREMENTS AND CONDITIONS FOR REINSTATEMENT

1. MS. KARGBO shall obey all federal, state, and local laws, and all laws and rules governing the practice of nursing in Ohio.



- 2. MS. KARGBO shall appear in person for interviews before the full Board or its designated representative as requested by the Board or its designee.
- 3. Prior to requesting reinstatement by the Board, MS. KARGBO shall submit a request to the Bureau of Criminal Identification and Investigation (BCII) to conduct a criminal records check of MS. KARGBO, including a check of Federal Bureau of Investigation (FBI) records, and shall cause BCII to submit MS. KARGBO's criminal records check reports to the Board. A request for reinstatement will not be considered by the Board until the completed criminal records check, including the FBI check, has been received by the Board.
- 4. Prior to requesting reinstatement by the Board, MS. KARGBO shall submit documentation of her full compliance with the terms and conditions imposed by the Order issued by the Commonwealth of Virginia, Department of Health Professions ("Virginia Board") dated March 27, 2015, with Exhibit 1: Final Decision and Order issued by the Georgia Board of Nursing, and the Virginia Board Order dated, August 28, 2015, and that her Virginia and Georgia licenses are fully reinstated and unencumbered.

Reporting Requirements of MS. KARGBO

- 5. MS. KARGBO shall sign release of information forms allowing health professionals and other organizations to submit requested documentation or information directly to the Board.
- 6. MS. KARGBO shall submit any and all information that the Board may request regarding her ability to practice nursing according to acceptable and prevailing standards of safe nursing practice.
- 7. MS. KARGBO shall not submit or cause to be submitted any false, misleading, or deceptive statements, information, or documentation to the Board or to employers or potential employers.
- 8. MS. KARGBO shall submit the reports and documentation required by this Order on forms specified by the Board. All reporting and communications required by this Order shall be made to the Compliance Unit of the Board.
- 9. **MS. KARGBO** shall submit the reports and documentation required by this Order to the attention of the Compliance Unit, Ohio Board of Nursing, 17 South High Street, Suite 400, Columbus, OH 43215-7410.
- 10. MS. KARGBO shall verify that the reports and documentation required by this Order are received in the Board office.
- 11. MS. KARGBO shall inform the Board within five (5) business days, in writing, of any change in address and/or telephone number.

DURATION

The Board may only alter the indefinite suspension imposed if: (1) MS. KARGBO submits a written request for reinstatement; (2) the Board determines that MS. KARGBO has complied with all conditions of reinstatement; and (3) the Board determines that MS. KARGBO is able to practice nursing according to acceptable and prevailing standards of safe nursing care based upon an interview with MS. KARGBO and review of the documentation specified in this Order.

This ORDER shall become effective immediately and is hereby entered upon the Journal of the Board for the 19th day of May, 2016.

TIME AND METHOD TO PERFECT AN APPEAL

Any party desiring to appeal shall file a Notice of Appeal with the Ohio Board of Nursing, 17 S. High St., Suite 400, Columbus OH 43215-7410, setting forth the order appealed from and stating that the agency's order is not supported by reliable, probative, and substantial evidence and is not in accordance with law. The notice of appeal may, but need not, set forth the specific grounds of the party's appeal.

A copy of such Notice of Appeal shall also be filed by the appellant with the Franklin County Court of Common Pleas, Columbus, Ohio. In filing a notice of appeal with the agency or court, the notice that is filed may be either the original notice or a copy of the original notice. Such notices of appeal shall be filed within fifteen (15) days after the mailing of the notice of the Ohio Board of Nursing's Order as provided in Section 119.12 of the Ohio Revised Code.
