CONSENT ORDER

The Virginia Board of Nursing ("Board") and Barbara A. Dooley, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Dooley's application for licensure by endorsement to practice as a professional nurse in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Barbara A. Dooley submitted an application for licensure by endorsement to practice as a professional nurse in Virginia, which was received by the Board on May 8, 2015. Ms. Dooley holds License No. RN9202868 to practice as a professional nurse in Florida, which is scheduled to expire on April 30, 2017. Her primary state of residence is Florida.
2. Ms. Dooley has been convicted of the following crimes in the Circuit Court for Broward County, Florida:
 - a. On July 18, 1985, she was convicted of one count of possession of cocaine, a felony.
 - b. On December 15, 1989, she was convicted of one count of possession of cocaine, a felony.
 - c. On November 8, 1993, she was convicted of one count of possession of cocaine, a felony.
 - d. On February 7, 1997, she was convicted of one count of possession of cocaine, a felony.
3. Ms. Dooley's date of sobriety is January 30, 1997.

4. Ms. Dooley entered the Florida Intervention Project for Nurses in 2003. She was successfully released early from the program on September 20, 2004, and received an unconditional license to practice nursing in Florida on September 22, 2004.

5. Ms. Dooley has had no relapses or other criminal convictions since 1997.

CONCLUSIONS OF LAW

1. Finding of Fact No. 2 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended (“Code”).

2. Ms. Dooley otherwise meets the requirements of §§ 54.1-3017 and 54.1-3018 of the Code.

CONSENT

Barbara A. Dooley, by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;

2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;

3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;

4. She waives all such right to an informal conference;

5. She admits to the Findings of Fact and Conclusions of Law contained herein waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;

6. She consents to the entry of the following Order affecting her application for licensure to practice professional nursing in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:


1. The application of Barbara A. Dooley for licensure by endorsement to practice professional nursing in the Commonwealth of Virginia is hereby APPROVED. Ms. Dooley shall be issued an unrestricted license to practice as a professional nurse in the Commonwealth.

2. Ms. Dooley is hereby REPRIMANDED.

3. Ms. Dooley shall maintain a course of conduct in her capacity as a professional nurse commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.

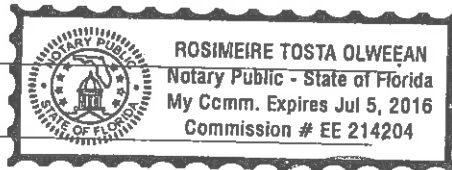
