**NOTICE OF HEARING**

Pursuant to §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11) of the Code of Virginia (1950), as amended (“Code”), Virginia Rumble, C.N.A., who, prior to its indefinite suspension by the Board of Nursing on April 3, 2013, held Certificate No. 1401-04078 to practice as a nurse aide in Virginia, is hereby given notice that a formal administrative hearing will be held in the presence of a panel of the Board of Nursing. The hearing will be held on July 15, 2015, at 9:00 a.m., at the offices of the Department of Health Professions, Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia 23233, at which time Ms. Rumble will be afforded the opportunity to be heard in person or by counsel.

At the hearing, Ms. Rumble has the following rights, among others: the right to representation by counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to present documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Rumble desires any witnesses to appear on her behalf, she must notify the Director of Administrative Proceedings, Department of Health Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in accordance with the Instructions for Requesting Subpoenas.

The purpose of the hearing is to receive and act upon Ms. Rumble’s application for reinstatement of her certificate to practice as a nurse aide in Virginia, to inquire into evidence that Ms. Rumble may have violated certain laws and regulations governing nurse aide practice in Virginia, and to receive and act upon Ms. Rumble’s petition for removal of a finding of neglect based on a singular occurrence, pursuant to an Order entered April 3, 2013, as more fully set forth in the Statement of Particulars below.

The burden rests upon Ms. Rumble, as the applicant, to demonstrate that she is capable of resuming the safe and competent practice as a nurse aide in Virginia and that her employment and personal history do not reflect a pattern of abusive behavior or neglect.

**STATEMENT OF PARTICULARS**

The Board alleges that:


1. Virginia Rumble, C.N.A., may have violated § 54.1-3007(1) of the Code and 18 VAC 90-25-100(1)(b) of the Regulations Governing Certified Nurse Aides (“Regulations”) in that on her application for reinstatement of her certificate to practice as a nurse aide which was received by the Board on January 9, 2015, Ms. Rumble answered “NO” to the question, “Have you ever had action or been denied a license or certificate in a health-related field?” when, in fact, she has had action taken against her certificate on two occasions as evidenced by the following:

a. By Board’s Order entered October 22, 2007, Ms. Rumble was issued a reprimand.

b. By Board’s Order entered April 3, 2013, her certificate to practice as a nurse aide was indefinitely suspended with a finding of neglect based on a single occurrence entered against her in the Virginia Nurse Aide Registry.

2. Ms. Rumble may have violated § 54.1-3007(2) and (5) of the Code and 18 VAC 90-25-100(2)(f) of the Regulations in that her certificate to practice as a nurse aide was indefinitely suspended by the Board’s Order entered April 3, 2013.
