ORDER

Pursuant to §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), a Special Conference Committee ("Committee") of the Virginia Board of Nursing ("Board") met on October 9, 2007, in Henrico County, Virginia, to inquire into evidence that Virginia Rumble, C.N.A., may have violated certain laws and regulations governing nurse aide practice in Virginia. Ms. Rumble was present and was not represented by counsel. Upon consideration of the evidence, the Committee adopts the following Findings of Fact and Conclusions of Law:

FINDINGS OF FACT

- 1. Virginia Rumble, C.N.A. was issued Certificate No. 1401-040478 to practice as a nurse aide in the Commonwealth of Virginia on September 11, 1993. Said certificate expires on September 30, 2009.
- 2. On December 9, 2006, during the course of her employment with Newport News Nursing and Rehabilitation Center, Newport News, Virginia, Ms. Rumble was overheard by a staff member down the hall yelling at a resident, telling her to be quiet, that she did not want to hear another word out of her, and that she was tired of her. Ms. Rumble denied making these statements, but acknowledged that she told the resident that she "should be glad that someone was cleaning her bottom."
- 3. The son of the resident appeared at the informal conference and spoke on behalf of Ms.

CONCLUSIONS OF LAW

Finding of Fact No.2 constitutes a violation of § 54.1-3007(5) of the Code.

ORDER

On the basis of the foregoing, the Committee hereby ORDERS as follows:

- 1. Virginia Rumble, C.N.A. is hereby REPRIMANDED.
- 2. Ms. Rumble shall maintain a course of conduct in her capacity as a nurse aide commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying on request.
