**CONSENT ORDER**

The Virginia Board of Nursing ("Board") and Sean Mapson, as evidenced by his signature hereto, enter into the following Consent Order affecting Mr. Mapson's application for certification by examination to practice as a nurse aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

**FINDINGS OF FACT**

1. Sean Mapson submitted an application for certification by examination to practice as a nurse aide which was received by the Board on August 7, 2012.
2. On November 19, 2010, Mr. Mapson was convicted of petit larceny in the City of Salem, Virginia, General District Court,
3. Mr. Mapson provided evidence that he successfully completed his obligations with the Court Community Corrections.

**CONCLUSIONS OF LAW**

1. Finding of Fact No. 2 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").
2. Otherwise, Mr. Mapson meets the requirements of § 54.1-3023 of the Code.

**CONSENT**

Sean Mapson, by affixing his signature hereon, agrees to the following:

1. He has been advised to seek advice of counsel prior to signing this document;

2. He acknowledges that without his consent, no legal action can be taken against him except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;

3. He acknowledges that he has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against him;

4. He waives all such right to an informal conference;

5. He admits to the Findings of Fact and Conclusions of Law contained herein and waives his right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;

6. He consents to the entry of the following Order affecting his application for certification by examination to practice as a nurse aide in Virginia.

### **ORDER**

WHEREFORE, it is hereby ORDERED:

1. The application of Sean Mapson for certification by examination to practice as a nurse aide is APPROVED. Upon successful completion of the NNAAP examination, Mr. Mapson shall be issued an unrestricted certificate to practice as a nurse aide in the Commonwealth.

2. Mr. Mapson is hereby REPRIMANDED.

3. Mr. Mapson shall maintain a course of conduct in his capacity as a certified nurse aide commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.

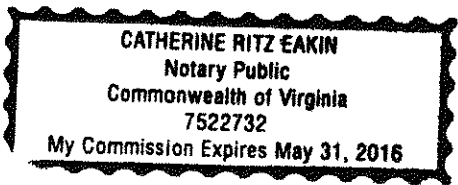
