CONSENT ORDER

By letter dated July 10, 2014 the Board of Nursing ("Board") noticed Kristin Boley, R.N., for a formal hearing. In lieu of proceeding to a formal hearing, the Board and Ms. Boley, as evidenced by their signatures affixed below, agree to enter into this Consent Order affecting the license of Ms. Boley to practice professional nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Kristin Boley, R.N., was issued License No. 0001-192349 to practice professional nursing by the Virginia Board of Nursing on August 24, 2004. Said license was summarily suspended by the Board on July 10, 2014. Ms. Boley's primary state of residence is Virginia.

2. On or about January 31, 2014, Ms. Boley was admitted to Winchester Medical Center, Winchester, Virginia, under an emergency custody order and was found to meet the criteria for temporary detention. On or about February 5, 2014, she was discharged with a diagnosis of post traumatic stress disorder and psychotic disorder.

3. On March 18, 2014, Ms. Boley was diagnosed with post traumatic stress disorder and unspecified psychosis. On a subsequent examination on March 28, 2014, Ms. Boley was diagnosed with Bipolar I disorder, severe with psychotic features.

4. On May 13, 2014, in an interview with an investigator for the Department of Health Professions, Ms. Boley's treating psychiatrist stated that in his professional opinion, Ms. Boley was not ready to return to work and that her paranoia and conspiracy thinking are concerning.

CONCLUSIONS OF LAW

Findings of Fact Nos. 2 and 3 constitute a violation of § 54.1-3007(6) of the Code of Virginia (1950), as amended ("Code").

CONSENT

Kristin Boley, R.N., by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her license except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. and § 54.1-2408.1 of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to a formal hearing before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. She waives all such rights to a formal hearing;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding wherein the Board is a party;
- 6. She consents to the entry of the following Order affecting her right to practice professional nursing in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. License No. 0001-192349 of Kristin Boley to practice professional nursing is INDEFINITELY SUSPENDED.
 - The license will be recorded as suspended and no longer current.
- 3. At such time as Ms. Boley shall petition the Board for reinstatement of her license, an administrative proceeding will be convened to determine whether she is capable of resuming the safe and competent practice of professional nursing. Ms. Boley shall be responsible for any fees that may be required for the reinstatement and renewal of the license prior to issuance of the license to resume practice.
 - 4. This suspension applies to any multistate privilege to practice professional nursing.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public inspection or copying upon request.
