documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Overstreet desires any

STATEMENT OF PARTICULARS

The Board alleges that:

1. Brenda Lee Overstreet, R.M.A., may have violated §54.1-3007(6) of the Code in that she may be unsafe to practice as a medication aide due to her admitted history of narcotic addiction.

2. Ms. Overstreet, may have violated §54.1-3007(2), (3), (5), (6) and (8) of the Code, 18 VAC 90-60-110(A)(2) and 18 VAC 90-60-120(2)(c), (d), (l) and (m) of the Regulations Governing the Registration of Medication Aides in that by her own admission, during the course of her employment with Smith Mountain Lake Retirement Village, Hardy, Virginia, from between or about March 2014, through July 21, 2014, she diverted multiple narcotics from the supply of Resident A, Resident B and Resident C and signed out medications for the residents on narcotic sign-out sheets.
