Pursuant to Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), you are hereby given notice that your certification to practice as a certified nurse aide in the Commonwealth of Virginia has been mandatorily suspended by the enclosed Order entered June 22, 2015. You are hereby advised that, pursuant to Section 54.1-2409.1 of the Code, any person who practices a profession or occupation after having their license or certificate to do so suspended shall be guilty of a felony. Please return your certificate to Jay P. Douglas, Executive Director of the Virginia Board of Nursing, at the above address, immediately upon receipt of this letter.

Section 54.1-2409 of the Code further provides that you may apply to the Board of Nursing ("Board") for reinstatement of your certificate, and shall be entitled to a hearing not later than the next regular meeting of the Board after the expiration of sixty days from the receipt of such reinstatement application. You have the following rights, among others: to be represented by legal counsel, to have witnesses subpoenaed on your behalf, to present documentary evidence and to cross-examine adverse witnesses. The reinstatement of your certificate shall require the affirmative vote of three-fourths of the members present of the Board of Nursing.

Should you wish to petition the Board of Nursing for reinstatement of your certificate, contact Jay P. Douglas, Executive Director, at the above address or (804) 367-4639.

The Court is of the opinion that it is compatible with the public interest, that the imposition of sentence be deferred upon the following conditions:

That the defendant cooperate fully with the request for information made by the Probation Officer, who is directed to conduct a thorough investigation and to file a presentence report with the Court.

The defendant shall undergo a substance abuse screening and if the screening indicates a substance abuse or dependence problem, an assessment shall be done as directed by the Probation Officer. The results of the screening and assessment if indicated shall be included in the pre-sentence report.

Sentencing is set for February 11, 2015 at 2:00 p.m. to which time these cases are continued and the defendant was allowed to depart.
