Dear Ms. Cale:

Pursuant to Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), you are hereby given notice that your license to practice nursing in the Commonwealth of Virginia has been mandatorily suspended by the enclosed Order entered November 29, 2007. You are hereby advised that, pursuant to Section 54.1-2409.1 of the Code, any person who practices a profession or occupation after having their license or certificate to do so suspended shall be guilty of a felony. Please return your license to Jay P. Douglas, Executive Director, at the above address, immediately upon receipt of this letter.

Section 54.1-2409 of the Code further provides that you may apply to the Board of Nursing ("Board") for reinstatement of your license, and shall be entitled to a hearing not later than the next regular meeting of the Board after the expiration of sixty days from the receipt of such reinstatement application. You have the following rights, among others: to be represented by legal counsel, to have witnesses subpoenaed on your behalf, to present documentary evidence and to cross-examine adverse witnesses. The reinstatement of your license shall require the affirmative vote of three-fourths of the members present of the Board of Nursing.

ORDER

In accordance with Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), I, Sandra Whitley Ryals, Director of the Virginia Department of Health Professions, received and acted upon evidence that Jamie L. Cale, L.P.N., was convicted of a felony charge in the Circuit Court of the City of Suffolk for the Commonwealth of Virginia, to wit: One (1) Count of Grand Larceny. A certified copy of the Sentencing Order is attached to this Order and is marked as Commonwealth's Exhibit No. 1.

WHEREFORE, by the authority vested in the Director of the Department of Health Professions pursuant to Section 54.1-2409 of the Code, it is hereby ORDERED that the license of Jamie L. Cale, L.P.N., to practice nursing in the Commonwealth of Virginia be, and hereby is, SUSPENDED.

Upon entry of this Order, the license of Jamie L. Cale, L.P.N., will be recorded as suspended and no longer current. Should Ms. Cale seek reinstatement of her license pursuant to Section 54.1-2409 of the Code, she shall be responsible for any fees that may be required for the reinstatement and renewal of her license prior to issuance of her license to resume practice.

Pursuant to Sections 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public inspection and copying upon request.



This case came before the Court for sentencing of the defendant, who appeared in person with her attorney, Jeff Gardy. The Commonwealth was represented by Marilyn Sallee.

On November 1, 2006, the defendant was found guilty of the following offense:

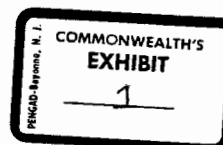
The presentence report was considered and is ordered filed as a part of the record in accordance with the provisions of Code §19.2-299.

Pursuant to provisions of Code §19.2-298.01, the Court has considered and reviewed the applicable discretionary sentencing guidelines and the guideline worksheets. The sentencing guidelines worksheets and the written explanation of any departure from the guidelines are ordered filed as a part of the record in this case.

Before pronouncing sentence, the Court inquired if the defendant desired to make a statement and if the defendant desired to advance any reason why judgment should not be pronounced.

The Court SENTENCES the defendant to:

Incarceration with the Virginia Department of Corrections for the term of Five (5) years. The total sentence imposed is Five (5) years.



This sentence shall run consecutively.

The Court **SUSPENDS** All of the Five (5) year sentence on time served, for a period of Five (5) years, for a total suspension of Five (5) years on time served of the Five (5) year sentence, upon the following conditions: The Court ordered the defendant to enter into and successfully complete the Day Reporting Center.

Good Behavior. The defendant shall be of good behavior for a period Five (5) years from the defendant's release from confinement.

Supervised Probation. The defendant is placed on probation on her release from incarceration, under the supervision of a Probation Officer for a period of Five (5) years, or unless sooner released by the court or by the probation officer. The defendant shall comply with all the rules and requirements set by the probation officer. Probation shall include substance abuse counseling, treatment and/or testing as deemed necessary by the Probation Officer.

Costs. The defendant shall pay the costs of court in the amount of \$380.00 within a payment schedule to be set up by her in the Suffolk Circuit Court Clerk's Office.

Restitution. The Court ordered restitution in the amount of \$397.00 made payable to: Wal-Mart to be paid jointly and severally with her co-defendant, Richard Hoffler, within a payment schedule set up by her in the Suffolk Circuit Court Clerk's Office.

Restitution, Court Costs and Fines. The defendant's restitution, court costs, and fines, if any, and interest thereon, shall become due and payable on the date the Court sentences the defendant in accordance with the agreement. The defendant shall enter into a payment plan with the Clerk of this Court for the payment of restitution, court costs, and fines, if any, as soon as practicable following his sentencing and release from incarceration and shall provide evidence of this payment plan to his probation officer.


DNA Analysis. The defendant is ordered to cooperate fully in providing a sampling of blood, saliva or tissue as required for DNA analysis pursuant to Section 19.2-310.2 of the Code of Virginia.

Credit For Time Served. The defendant shall be given credit for time spent in confinement while awaiting trial pursuant to Code §53.1-187.

The Court ordered the defendant to report to the Probation Department tomorrow morning by 9:00 a.m., to get

herself signed into the Day Reporting Center.


