CONSENT ORDER

The Virginia Board of Nursing ("Board") and Anissa J. Frasier, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Frasier's application for reinstatement of her license to practice practical nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- Anissa J. Frasier was issued License No. 0002-080914 to practice practical nursing by the Virginia Board of Nursing on August 6, 2009. Said license expired on January 31, 2012. Her primary state of residence is Virginia.
- 2. Ms. Frasier submitted an application for reinstatement of her license which was received by the Board on November 17, 2014.
- 3. From February 1, 2012 to August 5, 2014, Ms. Frasier practiced practical nursing on an expired license.

CONCLUSIONS OF LAW

- Finding of Fact No. 3 constitutes a violation of §§ 54.1-3007(3) and 54.1-3008(A)(2) of the Code of Virginia (1950), as amended ("Code").
- 2. The Board concludes that Ms. Frasier has demonstrated satisfactory evidence that she is prepared to resume practice in a safe and competent manner.

CONSENT

Anissa J. Frasier, by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her:
 - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting the application for reinstatement of her license to practice practical nursing in Virginia.

<u>ORDER</u>

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. Anissa J. Frasier is hereby REPRIMANDED.
- 2. The license of Anissa J. Frasier is hereby REINSTATED contingent upon payment of a MONETARY PENALTY of \$500.00 to the Board.
- 3. Ms. Frasier shall maintain a course of conduct in her capacity as a practical nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
