**AMENDED CONSENT ORDER**

---

**JURISDICTION AND PROCEDURAL HISTORY**

The Virginia Board of Nursing ("Board") and Pamela Frye Blake, L.P.N., as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Blake's license to practice practical nursing in the Commonwealth of Virginia.

**FINDINGS OF FACT AND CONCLUSIONS OF LAW**

1. Pamela Frye Blake, L.P.N. was issued License Number 0002-059508 to practice practical nursing on July 6, 2000, which is scheduled to expire on April 30, 2018. Her primary state of residence is Virginia.
2. By Term No. 1 of the Order of the Board entered May 17, 2015 ("Board's Order"), Ms. Blake was required to have a chemical dependency evaluation, with a written report of the evaluation submitted to the Board within 90 days of the entry of the Order, or by August 25, 2015.
3. Ms. Blake violated Term Number 1 of the Board's Order in that she was substantially late in completing the evaluation and submitting the required report. The evaluation dated May 2, 2016 was submitted to the Board on May 4, 2016.
4. Based upon the evaluator's assessment, Ms. Blake does not appear to require counseling at this time.

## CONSENT

Pamela Frye Blake, L.P.N., by affixing her signature to this Consent Order, agrees to the following:

1. I have been advised to seek advice of counsel prior to signing this document;
2. I am fully aware that without my consent, no legal action can be taken against me or my license except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 *et seq.*;
3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; the right to representation by counsel; and the right to cross-examine witnesses against me;
4. I waive all right to an informal conference;
5. I admit to the Findings of Fact and Conclusion of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
6. I consent to the entry of the following Order affecting my right to practice practical nursing in the Commonwealth of Virginia.

## ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

1. Pamela Frye Blake is REPRIMANDED.
2. The Board shall TAKE NO FURTHER ACTION at this time.
3. Pamela Frye Blake shall comply with all laws and regulations governing the practice of practical nursing in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.

Pursuant to Virginia Code § 54.1-2400.2(K), the Board considered whether to disclose or not disclose Ms. Blake's health records or health services.
