CONSENT ORDER

The Virginia Board of Nursing ("Board") and LaTrina Payne as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Payne's application for certification to practice as a certified nurse aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. LaTrina Payne submitted an application for certification by examination to practice as a certified nurse aide which was received by the Board on August 11, 2014.
- 2. On September 18, 2008, Ms. Payne was convicted of two counts of misdemeanor larceny, a crime of moral turpitude, in the Hampton, Virginia, General District Court. Ms. Payne was sentenced to 12 months in jail with 12 months suspended and placed on probation for a period of 2 years on each count. Ms. Payne was also ordered to pay restitution in the amount of \$1,197.60 within one year.

CONCLUSIONS OF LAW

- 1. Finding of Fact No. 2 constitutes a violation of §54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").
- 2. The Board concludes that Ms. Payne otherwise meets the requirements of §54.1-3023 of the Code.

CONSENT

LaTrina Payne, by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;

- 2. She acknowledges that without her consent, no legal action can be taken against her application except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her application to practice as a certified nurse aide in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. The application of LaTrina Payne for certification to practice as a nurse aide in Virginia is APPROVED. Upon successful completion of the NNAAP Examination, Ms. Payne shall be issued an unrestricted certificate to practice as a certified nurse aide.
 - 2. Ms. Payne is hereby REPRIMANDED.
- 3. Ms. Payne shall maintain a course of conduct in her capacity as a certified nurse aide commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
