ORDER

In accordance with §§ 2.2-4019, 2.2-4021 and 54.1-2400(10) of the Code of Virginia (1950), as amended

("Code"), an informal conference was conducted on behalf of the Board of Nursing ("Board") on April 21, 2015,

in Henrico County, Virginia. Crystal Rose, C.N.A., was present and was not represented by legal counsel. Judith

Piersall R.N. B.S.N., serving as Agency Subordinate for the Board, submitted a Recommended Decision for

consideration.

Based upon its review of the Recommended Decision of the Agency Subordinate, the Board makes the

following Findings of Fact and Conclusions of Law and issues the following Order.

FINDINGS OF FACT

1. Crystal Rose, C.N.A., was issued Certificate No. 1401-163674 to practice as a nurse aide in

Virginia on November 13, 2013. The certificate is scheduled to expire on November 30, 2015.

2. Ms. Rose submitted an application for registration by examination to practice as a medication

aide which was received by the Board on August 8, 2014.

3. By letter dated March 23, 2015, the Board of Nursing sent a Notice of Informal Conference

("Notice") to Ms. Rose notifying her that an informal conference would be held on April 21, 2015. The Notice

was sent by certified and first class mail to 201 Tam-O-Shanter Blvd., Apt. 7-B, Williamsburg, Virginia 23185, the

address of record on file with the Board of Nursing.

4. Ms. Rose provided evidence of completion of a medication aide training administered by Heart to

Heart Career Training.

CONCLUSIONS OF LAW

Crystal Rose, C.N.A., meets the qualifications of § 54.1-3042 of the Code.

ORDER

WHEREFORE, it is hereby ORDERED:

1. The application of Crystal Rose, C.N.A., for registration by examination to practice as medication aide is APPROVED. Upon successful completion of the Medication Aide examination, Ms. Rose

shall be issued an unrestricted registration to practice as a medication aid in the Commonwealth.

2. Ms. Rose shall maintain a course of conduct in her capacity as a nurse aide and medication aide commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.

Pursuant to § 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.

Pursuant to Section 54.1-2400(10) of the Code, Ms. Rose may, not later than 5:00 p.m., on June 8, 2015, notify Jay P. Douglas, M.S.M., R.N., C.S.A.C., F.R.E., Executive Director, Board of Nursing, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in writing that he/she desires a formal administrative hearing before the Board. Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated.
