You are hereby notified that an Informal Conference has been scheduled before the Board of Nursing ("Board") regarding your application for reinstatement of your certificate to practice as a nurse aide in the Commonwealth of Virginia following its suspension by the Board and your petition for removal of a finding of neglect based on a singular occurrence, pursuant to an Order entered April 2, 2015.

LEGAL AUTHORITY AND JURISDICTION:

- 2. The burden rests on you, as the applicant, to demonstrate that you are prepared to resume the safe and competent practice as a nurse aide.
- 3. In considering your application, the Committee will consider evidence that grounds exist to deny your application for reinstatement of your certificate to practice as a nurse aide, as more fully set out in the enclosed Statement of Allegations.
- 4. At the conclusion of the proceeding, the Committee is authorized to take any of the following actions:
- Approve your application and issue an unrestricted certificate to practice as a nurse aide.

- Approve your application and issue a reprimand, a monetary penalty, and/or a restricted certificate subject to terms and conditions.
 - Deny your application;
 - Refer the matter to the Board for a formal administrative hearing.

ABSENCE OF APPLICANT AND APPLICANT'S COUNSEL:

If you fail to appear at the informal conference, the Committee may proceed to hear this matter in your absence and may take any of the actions outlined above.

APPLICANT'S LEGAL RIGHTS:

You have the right to the information on which the Committee will rely in making its decision, to be represented by counsel at this proceeding, to subpoena witnesses and/or documents, and to present relevant evidence on your behalf.

REQUEST FOR A CONTINUANCE

Absent exigent circumstances, such as personal or family illness, a request for a continuance after April 5, 2017, will not be considered. If you obtain counsel, you should do so as soon as possible, as a motion for a continuance due to the unavailability of counsel will not be considered unless received by April 5, 2017.

OTHER IMPORTANT INFORMATION:

Pursuant to 18 VAC 90-25-81 of the Regulations Governing Certified Nurse Aides, the burden rests upon you, as the petitioner, to demonstrate that your employment and personal history do not reflect a pattern of abusive behavior or neglect.

STATEMENT OF ALLEGATIONS

The Board alleges that grounds exist to refuse to reinstate the certificate of Nicole Elise Jones, C.N.A. to practice as a nurse aide in that she violated Virginia Code § 54.1-3007(2) and 18 VAC 90-25-100(2)(f) of the Regulations Governing Certified Nurse Aides, in that her certificate to practice as a nurse aide was suspended by the Board on April 2, 2015.
