ORDER

JURISDICTION AND PROCEDURAL HISTORY

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), a Special Conference Committee of the Virginia Board of Nursing ("Board") held an informal conference on October 26, 2016, in Henrico County, Virginia, to receive and act upon Linda Satterwhite Toombs' application for reinstatement of her license to practice practical nursing in the Commonwealth of Virginia.

Linda Satterwhite Toombs, L.P.N., appeared at this proceeding and was not represented by legal counsel.

NOTICE

By letter dated September 2, 2016, the Board sent a Notice of Informal Conference ("Notice") to Ms. Toombs notifying her that an informal conference would be held on October 26, 2016. The Notice was sent by certified and first class mail to the legal address of record on file with the Board.

Upon consideration of the evidence, the Committee adopts the following Findings of Fact and Conclusions of Law and issues the Order contained herein.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Linda Satterwhite Toombs, L.P.N., was issued License Number 0002-035246 to practice practical nursing on November 30, 1984, which was indefinitely suspended on March 24, 2015. Her primary state of residence is Virginia.

2. By Order entered March 24, 2015, the Board indefinitely suspended Ms. Toombs' license to practice practical nursing for not less than one year based on findings that Ms. Toombs had obtained and attempted to obtain fraudulent prescriptions for herself and a family member and that Ms. Toombs had falsified information on two employment applications.

3. Ms. Toombs submitted an application on May 16, 2016 to the Board for reinstatement of her license to practice practical nursing in the Commonwealth of Virginia

4. Ms. Toombs submitted evidence that she had completed over 20 continuing education units with her application.

5. At the informal conference, Ms. Toombs stated that her goal was to return to practice in a nursing home setting instead of a physician's office, which she had previously found to be stressful.

6. Ms. Toombs is able to resume the safe and competent practice of nursing.

ORDER


Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

1. The application of Linda Satterwhite Toombs, L.P.N., for reinstatement of her license to practice practical nursing is APPROVED without restriction.

2. Ms. Toombs shall comply with all laws and regulations governing the practice of practical nursing in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.


