## **CONSENT ORDER**

The Virginia Board of Nursing ("Board") and Jennifer D. Presley, R.N., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Presley's license to practice nursing.

## FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Jennifer D. Presley, R.N., was issued License No. 0001-110948 to practice nursing by the Virginia Board of Nursing on August 23, 1988. Said license is set to expire on June 30, 2008, unless renewed.
- 2. On January 29, 1992, Ms. Presley entered into a Consent Order with the Board of Nursing placing her license on probation based on alcohol abuse. Ms. Presley successfully completed probation in 1994.
- 3. Ms. Presley is in violation of § 54.1-3007(6) of the Code of Virginia (1950), as amended ("Code") in that, by her own admission, she has a history of alcoholism for almost 20 years that has resulted in multiple admissions for alcohol treatment between approximately 1987 and her most recent inpatient treatment, from which she was discharged in December 2006.
- 4. Ms. Presley is in violation of § 54.1-3007(4) of the Code in that, on or about April 9, 2005, she was arrested for stealing an 18-pack of beer from a convenience store. As a result, on July 15, 2005, Ms. Presley was convicted of misdemeanor petit larceny in the General District Court of Caroline County, Virginia.
- 5. On January 27, 2007, Ms. Presley entered into a Recovery Monitoring Contract with the Health Practitioners' Intervention Program ("HPIP") pursuant to Chapter 25.1 of Title 54.1 of the Code and

18 VAC 76-10-10 *et seq.* of the Regulations Governing the HPIP. Ms. Presley is in compliance with her HPIP Contract.

## **CONSENT**

Jennifer D. Presley, R.N., by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq*. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said conference, the right to representation by counsel, and the right to cross-examine witnesses against her;
  - 4. She waives all such right to an informal conference;
- 5. She neither admits nor denies the Findings of Fact contained herein and waives her right to contest such Findings of Fact in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her right to practice nursing in Virginia.

## ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

The Board shall TAKE NO ACTION at this time, contingent upon Ms. Presley's compliance with all terms and conditions of the Recovery Monitoring Contract ("Contract") with the HPIP for the period specified in the Contract.

Any violation of the terms and conditions stated in this Order shall be reason for revoking the license of Jennifer D. Presley, R.N., and an administrative proceeding shall be held to decide whether her license

should be revoked. Ms. Presley shall be noticed to appear before the Board at such time as the Board is

notified that:

a. She is not in compliance with the terms and conditions of the HPIP, or has been

terminated from participation in the HPIP;

b. There is a pending investigation or unresolved allegation against her involving a

violation of law or regulation or any term or condition of probation or this Order; or

c. She has successfully completed the above-referenced period of participation in the

HPIP. However, upon receipt of Ms. Presley's participation in and compliance with the HPIP, the Board, at

its discretion, may waive Ms. Presley's appearance before the Board and close the matter without further

action.

Ms. Presley shall maintain a course of conduct in her capacity as a professional nurse commensurate

with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in

the custody of the Department of Health Professions as public record and shall be made available for public

inspection or copying upon request.
