NOTICE OF HEARING

Pursuant to §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11) of the Code of Virginia (1950), as amended (“Code”), Dianna Watson-Hall, who holds License No. 0002-066151 to practice practical nursing in Virginia, which expires on August 31, 2015, is hereby given notice that a formal administrative hearing will be held in the presence of a panel of the Board of Nursing. The hearing will be held on January 29, 2015, at 1:00 p.m., at the offices of the Department of Health Professions, Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia 23233, at which time Ms. Watson-Hall will be afforded the opportunity to be heard in person or by counsel.

At the hearing, Ms. Watson-Hall has the following rights, among others: the right to representation by counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to present documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Watson-Hall desires any witnesses to appear on her behalf, she must notify the Director of Administrative Proceedings, Department of Health Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in accordance with the Instructions for Requesting Subpoenas.


The purpose of the hearing is to inquire into evidence that Ms. Watson-Hall may have violated certain laws and regulations governing practical nursing practice in Virginia, as more fully set forth in the Statement of Particulars below.

STATEMENT OF PARTICULARS

The Board alleges that:

1. Dianna Watson-Hall, L.P.N., may have violated § 54.1-3007(2), (5), and (8) of the Code and 18 VAC 90-20-300(A)(2)(c) and (e) of the Regulations Governing the Practice of Nursing in that:
 - a. During the course of her employment with Lynmoore Assisted Living, Richmond, Virginia, between about December 2013 and about March 2014, she diverted Lantus (insulin), Neurontin (gabapentin), and Glipizide for her personal and unauthorized use. She accomplished the diversion of this medication by writing fraudulent telephone orders and faxing them to the pharmacy and personally taking possession of the medication upon delivery.
 - b. During the course of her employment with Charlottesville Health and Rehab Center, Charlottesville, Virginia, on or about November 18, 2013, she diverted Neurontin for her personal and unauthorized use.
2. Ms. Watson-Hall may have violated § 54.1-3007(4) of the Code in that on or about December 17, 2013, she was convicted in the Circuit Court of Chesterfield County, Virginia, of failure to return a vehicle, a misdemeanor involving moral turpitude.
