<u>ORDER</u>

Pursuant to §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), a Special Conference Committee ("Committee") of the Virginia Board of Nursing ("Board") met on February 9, 2015, in Henrico County, Virginia, to receive and act upon Jasmine Crockett's application for reinstatement of her certificate to practice as a nurse aide in Virginia. Ms. Crockett was present and was not represented by legal counsel.

Upon consideration of the evidence, the Committee adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Jasmine Crockett was issued Certificate No. 1401-137560 to practice as a nurse aide in the Commonwealth of Virginia on June 9, 2010. Said certificate was indefinitely suspended by an Order of the Board entered on November 29, 2012. This action was based on findings that Ms. Crockett failed to provide incontinent care to several residents assigned to her care. This action was also based on findings that following her employment termination for failing to report to a subsequent scheduled shift, Ms. Crockett posted a threat on Facebook to bomb her former employer, which she later indicated she had no recollection of due to "cognitive blackouts" she suffered from whenever she became angry or irritated.
- 2. Ms. Crockett submitted an application for reinstatement of her certificate to practice as a nurse aide, which was received by the Board on August 18, 2014.

3. By letter dated January 12, 2015, the Board sent a Notice of Informal Conference ("Notice") to Ms. Crockett notifying her that an informal conference would be held on February 9, 2015. By an Order of the Circuit Court of Middlesex County, Virginia entered on June 20, 2012, the 4. Court found that there was evidence sufficient to find Ms. Crockett guilty of threat to bomb, burn, destroy or damage a place of assembly, a felony, related to the threat she had posted on Facebook. The case was taken under advisement for a period of three years under terms and conditions. On May 21, 2014, the charge was dismissed based on Ms. Crockett's compliance with the terms and conditions of the June 20, 2012 Order.

- 5. At the informal conference, Ms. Crockett expressed remorse and regret for the actions that led to her felony charge. She stated that she planned to return to school, and that her future goal was to obtain an RN license.
- 6. In an interview with an investigator with the Virginia Department of Health Professions on November 21, 2014, the court's mental health clinician stated that he did not feel that Ms. Crockett had any major mental health issues and that she was not considered a danger to herself, or a danger to the safety and well being of the public.
- Ms. Crockett has not practiced as a CNA since her certificate was suspended in November 7. 2012.

CONCLUSION OF LAW

The Committee concludes that Ms. Crockett has demonstrated satisfactory evidence that she is prepared to resume practice in a safe and competent manner.

<u>ORDER</u>

On the basis of the foregoing, the Committee hereby ORDERS as follows:

- The application of Jasmine Crockett for reinstatement of her certificate to practice as a nurse 1. aide in Virginia is APPROVED. Upon successful completion of the NNAAP Examination, Ms. Crockett shall be issued an unrestricted certificate to practice as a nurse aide.
- 2. Ms. Crockett shall maintain a course of conduct in her capacity as a nurse aide commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Regulations Governing Certified Nurse Aides.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying on request.

Pursuant to Section 54.1-2400(10) of the Code, Ms. Crockett may, not later than 5:00 p.m., on April 3, 2015, notify Jay P. Douglas, M.S.M., R.N., C.S.A.C., F.R.E., Executive Director, Board of Nursing, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in writing that she desires a formal administrative hearing before the Board. Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated.
