ORDER

In accordance with §§ 2.2-4019, 2.2-4021 and 54.1-2400(10) of the Code of Virginia (1950), as

amended ("Code"), an informal conference was conducted on behalf of the Board of Nursing ("Board")

on March 6, 2007, in Henrico County, Virginia. Ms. French was not present nor was she represented by

legal counsel. E. Jane Elliott, R.N., Ph.D., serving as Agency Subordinate for the Board, submitted a

Recommended Decision for consideration.

On May 15, 2007, the Board met to receive and act upon the Recommended Decision of the

Agency Subordinate. Ms. French was not present nor was she represented by legal counsel.

Based upon its review of the Recommended Decision of the Agency Subordinate, the Board

makes the following Findings of Fact and Conclusions of Law and issues the following Order.

FINDINGS OF FACT

Ruth French, R.N., was issued license number 0001-186398 to practice professional 1.

nursing in the Commonwealth of Virginia on July 23, 2003. The license is current.

By letter dated February 1, 2007, the Board of Nursing sent a Notice of Informal 2.

Conference ("Notice") to Ms. French notifying her that an informal conference would be held on March

6, 2007. The Notice was sent by certified and first class mail to 139 Shober Lane, Monroe, Virginia

24574, the address on file with the Board of Nursing. Ms. French's certified mail receipt was returned to

the Board signed by Ms. French.

- 3. Ms. French is unsafe to practice due to mental health diagnoses which have precipitated three recent hospitalizations, one in 2005 and two in 2006.
- 4. While employed at Virginia Central Training Center, Madison Heights, Virginia, Ms. French was counseled for two medication errors:
 - a. On January 31, 2005, she administered medications to the wrong patient.
 - b. On February 10, 2005, she failed to administer medications to a patient.
- 5. Mr. Harold French, Ms. French's husband, appeared at the informal conference and stated that his wife had been in the emergency room on March 5, 2007, until 12:00 midnight, and he felt she could not make the trip to Richmond for the informal conference. Mr. French stated that Ms. French had back pain and became confused on March 5 as a result of the anxiety because of the pending informal conference. According to Mr. French, his wife's illness has been classified psychosomatic.
- 6. Ms. French was treated as an outpatient at the Virginia Baptist Hospital, Lynchburg, Virginia for Electric Shock Therapy ("ECT"), approximately seven times. Ms. French stated to the investigator for the Department that she had lost some memory subsequent to having ECT therapy.
- 7. Ms. French stated to the investigator for the Department that two of her hospitalizations were a result of overdosing on prescribed medication. Although she had suicidal ideations, the overdosing was an attempt to relieve pain, not an attempt to kill herself.
- 8. Ms. French is currently under the care of a psychiatrist, who, in a letter of August 22, 2005, stated: "[Ms. French] is not ready at this point to function as a Registered Nurse...and she and I both hope that one day, maybe a year or two down the road, she will be adequately healthy to function once again as a registered nurse."

CONCLUSIONS OF LAW

The Board concludes that:

- 1. Finding of Fact #8 constitutes a violation of § 54.1-3007(6) of the Code.
- 2. Finding of Fact #4 constitutes a violation of § 54.1-3007(5) of the Code.

ORDER

WHEREFORE, it is hereby ORDERED that the license of Ruth French, R.N., be, and hereby is, INDEFINITELY SUSPENDED for not less than two (2) years, and until such time as she can demonstrate to the Board that she is capable of resuming the safe and competent practice of nursing.

The license will be recorded as suspended and no longer current.

At such time as Ms. French shall petition the Board for reinstatement of her license, an administrative proceeding will be convened to determine whether she is capable of resuming the safe and competent practice of nursing. Ms. French shall be responsible for any fees that may be required for the reinstatement and renewal of the license prior to issuance of the license to resume practice.

This Order shall be applicable to Ms. French's multistate licensure privileges, if any, to practice professional nursing in the Commonwealth of Virginia.

Since Ms. French failed to appear at the informal conference, this Order shall be considered final. Ms. French has the right to appeal this Order directly to the appropriate Virginia circuit court. As provided by Rule 2A:2 of the Supreme Court of Virginia, Ms. French has thirty (30) days from the date of service (the date she actually received this decision or the date it was mailed to her, whichever occurred first) within which to appeal this decision by filing a Notice of Appeal with Jay P. Douglas, R.N., M.S.M., C.S.A.C., Executive Director, Board of Nursing, at 6603 West Broad Street, Richmond, Virginia 23230. In the event that this decision is served by mail, three (3) days are added to that period.
