NOTICE OF HEARING

Pursuant to §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11) of the Code of Virginia (1950), as amended (“Code”), Angela R. Rorrer, R.N., who, prior to its suspension by the Board of Nursing on September 29, 2011, held License No. 0001-127241 to practice professional nursing in Virginia, is hereby given notice that a formal administrative hearing will be held in the presence of a panel of the Board of Nursing. The hearing will be held on January 28, 2015, at 11:00 a.m., at the offices of the Department of Health Professions, Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia 23233, at which time Ms. Rorrer will be afforded the opportunity to be heard in person or by counsel.


At the hearing, Ms. Rorrer has the following rights, among others: the right to representation by counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to present documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Rorrer desires any witnesses to appear on her behalf, she must notify the Director of Administrative Proceedings, Department of Health Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in accordance with the Instructions for Requesting Subpoenas.

The purpose of the hearing is to inquire into evidence that Angela R. Rorrer, R.N., may have violated certain terms and conditions imposed on her as set forth in the Order of the Board entered on September 29, 2011, and to inquire into evidence that Ms. Rorrer may have violated certain laws governing professional nursing practice in Virginia, as more fully set forth in the Statement of Particulars below.

STATEMENT OF PARTICULARS

The Board alleges that Angela R. Rorrer, R.N., may have violated § 54.1-3007(6) of the Code and Term No. 5 of the Order entered September 29, 2011, which required her to comply with all terms and conditions of the Health Practitioners' Monitoring Program ("HPMP") in that on or about August 21, 2014, Ms. Rorrer was dismissed from the HPMP due to noncompliance. Specifically, on or about July 24, 2014, by her own admission, Ms. Rorrer submitted a medication journal wherein she falsely reported consuming eight out of ten prescribed Percocet (oxycodone/APAP, Schedule II), when, in fact, she had consumed all ten of the tablets. Further, Ms. Rorrer provided her therapist with two Tylenol tablets to waste, instead of two Percocet tablets as indicated on the Narcotic Medication Use and Disposal Form. Subsequently, the HPMP recommended that Ms. Rorrer attend residential treatment; however, she failed to do so.
