### **CONSENT ORDER**

The Virginia Board of Nursing ("Board") and Shanna Chiles, L.P.N., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Chiles' license to practice practical nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

## FINDINGS OF FACT

- 1. Shanna Chiles, L.P.N. was issued License No. 0002-058894 to practice practical nursing by the Virginia Board of Nursing on September 17, 1999. Said license expired on June 30, 2014, was renewed on July 16, 2014, and is now set to expire on June 30, 2016. Her primary state of residence is Virginia.
- 2. During the course of her employment with Tidewater Physicians Multispecialty Group, Hidenwood Family Medicine, Newport News, Virginia, between July 1 and July 15, 2014, Ms. Chiles practiced practical nursing after her license had expired.

## **CONCLUSIONS OF LAW**

Finding of Fact No. 2 constitutes a violation of §§ 54.1-3007(3) and 54.1-3008(A)(2) of the Code of Virginia (1950), as amended ("Code").

## CONSENT

Shanna Chiles, L.P.N. by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;

- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her:
  - She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her right to practice practical nursing in Virginia.

#### **ORDER**

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. Shanna Chiles, L.P.N. shall pay a MONETARY PENALTY of \$100.00 to the Board within 90 days of the entry of this Order.
- 2. Ms. Chiles shall maintain a course of conduct in her capacity as a practical nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.
- 3. Any violation of the terms and conditions of this Order or of any law or regulation affecting the practice of nursing in the Commonwealth of Virginia shall constitute grounds for the suspension or revocation of the license of Ms. Chiles, and an administrative proceeding shall be convened to determine whether such license shall be suspended or revoked.
